#### STATEMENT OF ISSUE

This item provides information to the Capital Region Transportation Planning Agency (CRTPA) on the activities of the Technical Advisory Committee (TAC), the Citizens Multimodal Advisory Committee (CMAC), and the Leon County Transportation Disadvantaged Coordinating Board (TDCB). The TAC and CMAC met on January 7, 2014, after the agenda for the CRTPA Board was delivered to Board Members. This item provides Committee Actions for CRTPA Board consideration.

#### CRTPA SUBCOMMITTEE ACTIONS

**TAC and CMAC:** The TAC and the CMAC met on Tuesday, January 7, 2014, and took action on the following items:

- **Minutes of the November 5, 2014 Committee Meetings** – Both committees approved their respective minutes.
- **2014 Committee Meeting Calendar** – Both committees approved their respective Committee Calendar for 2014.
- **Fiscal Year (FY) 2014-FY 2018 Transportation Improvement Program Amendment** – Both committees recommended approval of the FY 2014-FY 2018 TIP Amendment.
- **Draft Fiscal Year (FY) 2015 – FY 2019 Work Program** – Both committees recommended approval of the Draft FY 2015- FY 2019 Work Program.

- **CRTPA Roundabout Policy** –Both committees had discussion on the proposed roundabout resolution prepared for the CRTPA Board.

**TAC Action:** The TAC made a recommendation that the Roundabout Resolution be tabled from the January 13, 2014 CRTPA Board Meeting and brought back for further discussion at the February 25, 2014 TAC Meeting and March 10, 2014 CRTPA Board Meeting. The TAC was concerned that the language is written in such a way that extensive evaluations of roundabouts would be required for every study and improvement consideration, even in instances where it was not a logical consideration (such as in canopy road areas).

**CMAC Action:** The CMAC made a motion to recommend approval of the Roundabout Resolution.

**CMAC Public Comment:**

The CMAC had one member of the public address the committee and the Speaker Form is provided as ***Attachment 1***. The comments received were regarding resurfacing projects and the addition of bicycle lanes.

**TDCB:** The Transportation Disadvantaged Coordinating Boards in Gadsden, Jefferson, Leon and Wakulla Counties have not met since the last CRTPA meeting. Their next meetings are as follows:

- Leon County – January 15, 2014 2 PM, location to be announced.
- Jefferson County – February 14, 2014 at 10 AM, Courthouse Annex. This meeting will be heard after the Annual Public Hearing.
- Gadsden County – February 14, 2014 at 2 PM, Library – Main Branch. This meeting will be heard after the Annual Public Hearing.
- Wakulla County – February 12, 2014 at 10 AM, Senior Citizens Center, Crawfordville. This meeting will be heard after the Annual Public Hearing.
