

The meeting was called to order by the Chairperson at 1:00 PM, with a quorum present.

Board Action: Commissioner Maddox made a motion to approve the consent agenda without Agenda Item 2.C, which was pulled for discussion by CRTPA Attorney Mr. Williams. Commissioner Madison seconded and the motion was unanimously passed.

# 3. <u>CONSENT ITEMS PULLED FOR DISCUSSION</u> CRTPA Technical Advisory Committee and Citizens Multimodal Advisory Committee Draft Bylaws

Mr. Williams noted that these items should be broken into separate motions (Option 1, 4, 2, 3, then 5). He stated that the disbanding of the Citizens Advisory and the Multimodal Advisory committees should only happen after the new Citizens Multimodal Advisory Committee has been formed. Mr. Williams stated that there were no substantive changes made to the agenda item, and this was only a procedural correction.

Board Action: Option 1-Commissioner Maddox made the motion to approve option 1 as presented by staff. Commissioner Miller seconded and the motion was unanimously passed. Option 4-Commissioner Miller made the motion to approve option 4 as presented by staff. Commissioner Madison seconded and the motion was unanimously passed. Option 2-Commissioner Madison made the motion to approve option 2 as presented by staff. Commissioner Dailey seconded and the motion was unanimously passed. Option 3-Commissioner Maddox made the motion to approve option 3 as presented by staff. Commissioner Miller seconded and the motion was unanimously passed. Option 5-Commissioner Miller made the motion to approve option 5 as presented by staff. Commissioner Maddox seconded and the motion was unanimously passed.

## 4. <u>ROLL CALL VOTE AGENDA ITEMS</u>

A. Fiscal Year (FY) 2013 – FY 2017 Transportation Improvement Program (TIP)

The CRTPA FY 2013 – FY 2017 TIP has been developed for Board adoption. The TIP contains those projects that received funding in the Florida Department of Transportation's FY 2013 – FY 2017 Work Program.

Board Action: Prior to the discussion of the CRTPA FY 2013 - FY 2017 TIP, Commissioner Daily made a motion to schedule a meeting at the airport to address airport funding and schedule a facility tour. Commissioner Maddox seconded the motion and the motion was unanimously passed.

Commissioner Miller discussed Orchard Pond Greenway project and questioned if the project was consistent with the Comprehensive Plan and Long Range Transportation Plan, as well as how it fits into the CRTPA process. Mr. Reed stated the project was identified as a need on the CRTPA's Regional Mobility Plan (RMP) and that it received a state infrastructure bank loan. FDOT approved the concept based on their analysis, but still had to go through further FDOT processes and stated the funding was only available this year. He noted that there will have to be proof of the ability to pay the loan back to FDOT. He also noted this project has not removed/replaced any CRTPA projects. Furthermore, he noted this funding would have to be paid back along with a demonstration of the mechanism for repayment of the funds and that process was not completely analyzed, as of this date. Commissioner Merritt discussed improvements on US Highway 319. He noted that Wakulla County will fund their intersection improvements. Mr. Reed noted those projects would better fit into the Transportations Systems Management (TSM) process and will be addressed with the Priority Project Lists that will be reviewed later this year in September.

Board Action: Commissioner Dailey made a motion to accept the Fiscal Year (FY) 2013 – FY 2017 Transportation Improvement Program (TIP). Commissioner Maddox seconded the motion. A roll call vote was conducted and the motion was unanimously passed.

## 5. CRTPA DISCUSSION (60 MINUTES)

### A. Sixth Avenue (Tallahassee) Pedestrian Project (Action) (10 minutes)

Consultant staff will present information regarding this project which involves the construction of sidewalks on Sixth Avenue from Monroe Street to Gadsden Street in Tallahassee.

Mr. Terry McKloski, URS Corp. outlined the Sixth Avenue (Tallahassee) Pedestrian Project. He discussed the project including two concept alternatives that were presented to the Board.

Commissioner Proctor discussed traffic and safety issues within the area.

## Board Action: This item was an informational item, therefore no action was taken.

## B. I-10 Interstate Master Plan (Information) (15 minutes)

Consultant staff will provide an update on the development of the I-10 Interstate Master Plan.

Mr. Richard Barr, Kimly-Horn and Associates provided a status report. He stated this project started last year and provided a schedule, noting the project was currently on schedule. He outlined the objectives of the study. He stated this study consists of three parts and this one was the Jefferson, Leon and Gadsden counties section which is 75 miles. Mr. Barr noted the analysis included an integrated plan that was economically efficient, environmentally sensitive and a vision for 2040. He noted the analysis of existing conditions and provided updates to the citizens of Jefferson, Leon and Gadsden counties. Mr. Barr provided results from the analysis for intersections and various segments. He outlined the next steps stating the item would be back before the board at the September board meeting.

### Board Action: This item was an informational item, therefore no action was taken.

### C. Welaunee Interchange (Action) (15 minutes)

Options associated with the potential study of an Interstate 10 interchange at Welaunee Boulevard will be discussed. A resolution of support for the interchange is offered for Board consideration.

Mr. Reed provided a summary of this project. He discussed traffic alternatives when traveling south from I-10 and would be designed to better accommodate truck traffic. Commissioner Croley stated the trucks on Capital Circle (at I-10) are a hazard due to the volume and this could possibly be a good thing. Mr. Reed also discussed the need for eastwest connectors. Commissioner Miller stated that currently there are no residential uses within the area. Commissioner Ziffer wanted to note that the funding was not currently within the budget that would be discussed at the regular City Commission meeting on June 27<sup>th</sup>.

Board Action: Commissioner Proctor made a motion to adopt and support a resolution move forward with a conceptual review of the interchange for the future. Commissioner Madison seconded the motion. The motion was unanimously passed.

**D. Transportation Management Area Certification (Information) (10 minutes)** Every three (3) years, the CRTPA is federally certified from the Federal Highway Administration. This year's certification visit from the FHWA and its partners is scheduled to occur on June 26 & June 27, 2012.

Shakira Crandol, FHWA, provided information on Transportation Management Area Certification. She outlined the certification process and the review and re-certification timelines. She stated the process includes a desk audit, site visit, report and a close-out presentation.

The purpose of this item is to amend the CRTPA Fiscal Year (FY) 2013 - FY 2017 Transportation Improvement Program (TIP) to revise two (2) projects to reflect the following:

- Wakulla County Bike Lane/Sidewalk (Project #4301491): Amend project to allocate funding to the Ochlockonee Bay Trail Phase 5A (located in Wakulla County) and add design funding to FY 2013 as well as revise funds for FY 2014.
- Trails & Greenway Bike Path/Trail (Project #4301511): Amend project to allocate • FY 2013 funding to Project #430191- (Wakulla County Bike Lane/Sidewalk -Ochlockonee Bay Trail Phase 5A, above) in FY 2013.

# **RECOMMENDED ACTION**

### **CRTPA SUBCOMMITTEE ACTIONS**

The CRTPA's two (2) subcommittees (Citizens Mulitmodal Advisory Committee and Technical Advisory Committee) met on September 11, 2012 and voted to recommend <u>approval</u> of this amendment at their respective meetings.

### HISTORY AND ANALYSIS

The CRTPA annually adopts a Transportation Improvement Program to identify those projects in the region that have received state and federal funding. Frequently, the TIP needs to be formally amended to reflect project changes such as the addition or deletion of a project, changes in project funding and changes in project scope.

Two projects are proposed to be revised in the FY 2013 - FY 2017 TIP:

### Wakulla County Bike Lane/Sidewalk (Project #4301491)

This project is identified in the FY 2013 – FY 2017 TIP to fund construction of bicycle and pedestrian projects in Wakulla County in FY 2013 and FY 2014. The purpose of this amendment is to allocate the funds to a specific project: The Ochlockonee Bay Trail (Phase 5A), consistent with direction from Wakulla County. Additionally, the amendment proposes adding additional funds in FY 2013 to the project from funding dedicated to CRTPA Trails and Greenways (Project #4301511, below), which identifies funding for trail and greenway projects in the CRTPA region. Furthermore, a portion of the funds programmed in FY 2014 (\$100,000) are proposed to be used for project management activities associated with CRTPA projects and placed in the Unified Planning Work Program in the same fiscal year.

Trails & Greenway Bike Path/Trail (Project #4301511)

This project is identified in the FY 2013 – FY 2017 TIP to construct trails and greenway projects in the CRTPA region. In the current fiscal year (FY 2013), \$216,200 is programmed. In order to allocate the funding to an eligible project, an amendment is proposed to place the funds on Project #4301491 (Wakulla Bike Lane/Sidewalk - Ochlockonee Bay Trail Phase 5A, above) in FY 2013.

The following provides details regarding the above two projects proposed to be revised in the CRTPA FY 2013 – FY 2017 TIP:

Project FM#: 4301491
 Project Description: Wakulla County Bike Lane/Sidewalk. Allocate funding to the Ochlockonee Bay Trail, Phase 5A; add design funding in FY 2013 (\$216,200); revise funding in FY 2014 to reduce funding by \$100,000 for use in CRTPA project management activities in the agency's Unified Planning Work Program.



## STATEMENT OF ISSUE

Staff is seeking approval of the FY 2014 – FY 2018 Regional Mobility Plan (RMP) Priority Project List (PPL) (included as *Attachment 1*). The RMP PPL contains multimodal projects identified in the agency's adopted Long Range Transportation Plan ("The Regional Mobility Plan") and is one of the priority project lists annually adopted by the CRTPA to provide guidance to the Florida Department of Transportation (FDOT) as it proceeds with development of the Annual State Work Program.

### **RECOMMENDATIONS BY CRTPA SUBCOMMITTEES**

On September 11, 2012, the CRTPA's two (2) committees (Citizens Multimodal Advisory Committee and Technical Advisory Committee) recommended CRTPA <u>approval</u> of the FY 2014 - FY 2018 Regional Mobility Plan Priority Project List.

## **RECOMMENDED ACTION**

Option 1: Adopt the FY 2014 - FY 2018 Regional Mobility Plan Priority Project List.

## HISTORY AND ANALYSIS

Annually, the CRTPA adopts priority project lists (PPLs) that identify, in ranked order, the agency's transportation project priorities. These lists are submitted to the Florida Department of Transportation (FDOT) to provide guidance as the agency proceeds with development of the Annual State Work Program, a five-year document identifying state and federally funded transportation projects.

Projects that receive funding in the annual State Work Program are then incorporated into the CRTPA's annual Transportation Improvement Program (TIP).

The CRTPA annually adopts the following PPLs:

**Regional Mobility Plan (RMP) PPL-** Identifies bicycle, pedestrian, roadway and transit projects (<u>Project source</u>: The Long Range Transportation Plan ("The Regional Mobility Plan")) **Transportation Enhancements PPL** – Identifies community-based projects that expand travel choices and enhance the transportation experience (<u>Project source</u>: eligible enhancement projects solicited by the CRTPA every two (2) years and submitted by local governments and community groups for funding)

**Transportation Systems Management (TSM) PPL** – Identifies low cost (typically intersection) improvements to the existing transportation system that can be constructed in less than two years and have gone through a required FDOT process in order to be considered eligible for funding (<u>Project source</u>: FDOT provides a list of eligible projects)(<u>NOTE</u>: The TSM PPL identifies projects in Leon County. TSM projects within Gadsden, Jefferson and Wakulla counties are identified by the local governments in consultation with FDOT District 3).

**Strategic Intermodal System (SIS) PPL** – Identifies roadways on the Strategic Intermodal System (SIS) (<u>Project source</u>: SIS facilities that have been identified for transportation improvement in the RMP)

**Tallahassee Regional Airport PPL** – Identifies Tallahassee Regional Airport project consistent with the adopted Airport Master Plan (<u>Project source</u>: projects identified by The Tallahassee Regional Airport and provided to the CRTPA for adoption)

**StarMetro PPL** – Identifies transit projects consistent with StarMetro's adopted Transit Development Plan (<u>Project source</u>: projects identified by StarMetro and provided to the CRTPA for adoption)

# **Regional Mobility Plan PPL**

The Draft FY 2014 – FY 2018 Regional Mobility Plan PPL is comprised of the projects identified in the CRTPA's Regional Mobility Plan that was adopted in November 2010. Due to the multimodal nature of the plan, the RMP PPL provides an integrated listing of bicycle, pedestrian, roadway and transit\* projects. Furthermore, the RMP PPL maintains the ranked order of the projects as contained within adopted RMP. This order was generated by applying points to the identified projects based upon the RMP's adopted Goals and Objectives.

\*Note: Transit projects on the RMP PPL list that propose service expansion are identified with an asterisk (\*) which notes that local operations funding is required prior to receipt of state and/or federal funds.

### Changes from last year's (FY 2013 - FY 2017) RMP PPL

This year's RMP PPL updates last year's (FY 2013 – FY 2017) RMP PPL by removing those projects from the PPL that have received funding in the most recent State Work Program (FY 2013 - FY 2017). Specifically, the following three (3) funded projects have been removed:

- Quincy By-Pass (SR 12 to US 90): construct new road
- Franklin Boulevard (Cascades Park to Tennessee St.): sidewalk funding
- Orange Avenue (Capital Circle, SW to Lake Bradford Road): sidewalk funding

Consistent with the direction provided by the CRTPA Board for the last four (4) years of PPL development, staff proposes to maintain the \$1 million minimum set-aside for bicycle and pedestrian projects as the agency's number one funded project prior to the FDOT seeking funding for the other projects on the PPL.

## PUBLIC INPUT

A public meeting to present the CRTPA's Draft FY 2014 – 2018 Priority Project Lists to the public was held on Thursday, August 30, 2012 at the Tallahassee Senior Center. Information regarding the meeting was placed on the CRTPA's website (<u>www.crtpa.org</u>) and an e-mail message regarding the meeting was sent to the agency's transportation partners. CRTPA staff provided a PowerPoint presentation to attendees during the meeting. *Attachment 2* provides a written comment received at the meeting.

# NEXT STEPS

Subsequent to adoption of the CRTPA FY 2014 – FY 2018 PPLs (including the RMP PPL), the lists will be provided to the FDOT for use as the agency proceeds with development of the Draft FY 2014 – FY 2018 Annual State Work Program.

The Draft Annual State Work Program is scheduled to be presented to the CRTPA Board by the FDOT at the November 26, 2012 CRTPA meeting. Subsequent to release of the Draft State Work Program, CRTPA staff will initiate development of the CRTPA FY 2014 – FY 2018 Transportation Improvement Program (TIP) incorporating those transportation projects in the CRTPA region that have received state and federal funding.



### HISTORY AND ANALYSIS

Annually, the CRTPA submits priority project lists (PPLs) to the Florida Department of Transportation (FDOT) for funding consideration in development of the DRAFT FDOT Annual Work Program. One of these lists, the Transportation Systems Management (TSM) list, identifies relatively low cost improvements to the existing transportation system that can be constructed in less than two years (such as intersection improvements).

In order to be considered for funding by the FDOT, TSM projects must be included on the FDOT Candidate List. Associated with the FDOT Candidate List is a TSM project process developed by the FDOT. *Attachment 2* provides a description of this process and how TSM projects are placed on the FDOT Candidate TSM list.

The DRAFT FY 2014 – 2018 TSM Priority Project List contains the listing of eligible TSM projects in proposed priority order. Included on this list is an analysis of each TSM project. A project analysis providing available information related to the following is provided for each project:

- <u>Safety Data</u>: Available safety data with each candidate project's traffic study was reviewed. This information is summarized in the attachment.
- <u>Level of Service Information</u>: Information related to the roadway/intersection level of service was obtained through a number of means including an analysis by the City of Tallahassee's (COT) Growth Management Department, information developed by the COT Traffic Engineering Division and information contained within the project's traffic study from the FDOT.
- <u>Mobility Impact</u>: Information related to *pedestrian demand* was identified for each TSM candidate project. This information was obtained from available data including an analysis conducted as part of development of the 2004 Tallahassee-Leon County Bicycle and Pedestrian Master Plan (for those projects located in Leon County). Information regarding *sidewalk availability* was identified as well as information related to *availability of transit* at each TSM candidate project's location is also included.

Due to limited FDOT funding for TSM projects and the fact that many of the projects on the TSM PPL will require additional funding for construction, coordination between the CRTPA and FDOT to identify other funds for use on selected projects will likely be required.

## Changes From Last Year's (FY 2013 - FY 2017) TSM PPL

Significant changes to this year's TSM PPL have occurred and are detailed below:

- <u>Project Addition</u>: This year's TSM PPL includes the addition of new projects associated with improving five (5) intersections along Crawfordville Road (SR 61) in Wakulla County. Specifically, the following projects have been added to the list:
  - <u>SR 61 @ US 98</u>
  - SR 61 @ Arran Road/Martin Luther King, Jr. Memorial Blvd. (Lower Bridge Road)
  - SR 61 @ Wakulla-Arran Road
  - <u>SR 61 @ Ivan Church Road (northern intersection)</u>
  - SR 61 @ Bloxham Cutoff (SR 267)

The FDOT, in coordination with Wakulla County and the CRTPA, is currently refining the above proposed improvements including developing detailed project cost estimates. As a result, the projects have been collapsed on the TSM PPL into one project. The projects are proposed to be ranked number one (#1) on the TSM PPL.

- <u>Project Removal</u>: Last year's number one (#1) ranked project (Pensacola Street at Dupree Street construct a westbound right turn lane) has been removed due a request by FDOT that the project be removed due to it serving exclusively an apartment complex and not a local street.
- <u>Project Removal</u>: Last year's number four (#4) ranked project (Capital Circle, NE at US 90 construct an eastbound right turn lane) has been removed due to the project receiving funding in the State Work Program.
- <u>Project Removal</u>: Last year's number six (#6) ranked project (Capital Circle, NW at Old Bainbridge Rd – construct a northbound right turn lane and southbound left turn lane) has been removed due recent receipt of funding. This push-button FDOT project has been added to the FY 13 – FY 17 CRTPA Transportation Improvement Program (TIP).

## PUBLIC INPUT

A public meeting to present the CRTPA's Draft FY 2014 – 2018 Priority Project Lists to the public was held on Thursday, August 30, 2012 in the Tallahassee Senior Center. Information regarding the meeting was placed on the CRTPA's website (<u>www.crtpa.org</u>) and an e-mail message regarding the meeting was sent to the agency's transportation partners.

## NEXT STEPS

Subsequent to adoption of the CRTPA FY 2014 – FY 2018 PPLs, the lists will be provided to the FDOT for use as the agency proceeds with development of the Draft FY 2014 – FY 2018 Annual State Work Program.

The Draft Annual State Work Program is scheduled to be presented to the CRTPA Board by the FDOT at the November 26, 2012 CRTPA meeting. Subsequent to release of the Draft State Work Program, CRTPA staff will initiate development of the CRTPA FY 2014 – FY 2018 Transportation Improvement Program (TIP) incorporating those transportation projects in the CRTPA region that have received state and federal funding.

#### The Transportation Systems Management (TSM) Project Process:


- □ The TPO, a local government or a citizen requests that FDOT study an intersection (which must include at least one State roadway). The FDOT will then complete the study within 12 weeks (dependent on work load).
- If a study has already been performed, then that study can be submitted to the FDOT ("Signed and Sealed by a Profession Engineer registered in the Sate of Florida") for review and approval.
- Once complete, if the study indicates that an improvement is warranted and would require right-of-way purchase or is too costly (over \$200,000) to be a 'push button' (fast response type) or regular traffic operations project (goes through the normal bidding process), then the project is placed on the Candidate TSM Project List.
- □ In order to be selected as a TSM work program project, the project must have a completed concept (unless the project is to be developed under a JPA and/or the FDOT is providing money to another entity to construct the project). A concept identifies the improvements and the associated present day construction and right of way cost.
- Due to FDOT staff reductions, District 3's general consultant has been assigned responsibility for TSM concept report development and is limited to 4 or 5 per year across the district.
- Typically, the FDOT sends the CRTPA the Candidate TSM Project List (in no priority order) in July for review and requests that the CRTPA finalize the project priority list by September 1.
- In the past, FDOT D-3 Traffic Operations has been allocated \$2 million annually for TSM projects. This will increase to \$2.75 Million for FY 2010. Due to this limited funding, typically (depending on the complexity of the project) only the TPO's top TSM candidate project is funded annually. This \$2.75 million must cover 4 TPO areas in the district. And, if any funds remain, consider some of the smaller counties that are not covered by a TPO area if they have candidate TSM project needs.
- Development of a concept report for a project to move forward with production typically takes 6 months. Due to this timeline, the FDOT annually reviews the current TSM priority list in December and selects projected candidate projects to be funded in the next year's Work Program cycle. In the past 2 years, the FDOT D3 Traffic Operations office has solicited input from the TAC in this selection process. Typically, the next unfunded TSM project priority would move to number one upon funding of the number one TSM project. One reason for this is to provide consistency to the FDOT on what projects are important to the CRTPA as well as to ensure adequate time for the development of a completed concept prior to inclusion in the FDOT Annual Work Program. However, this does not pre-empt other candidate projects from being added to the list as they are identified. Safety issues or critical need related to these new projects may override the typical process for the next unfunded candidate project to move up to number one and is certainly understood by FDOT.

Note: The Traffic Operations office aggressively seeks opportunities to include any candidate project improvements in larger Work Program projects or the Strategic Highway Safety Plan projects. Every 6 months, the Work Program of projects is reviewed to see if any new projects encompassing the candidate TSM project area has been funded. In addition, opportunities to implement improvements through developers are also aggressively pursued. This helps stretch the available TSM funding and maximizes its potential to fund TSM projects.

The TE PPL identifies projects that expand travel choices and enhance the transportation experience by improving the cultural, historic, aesthetic and environmental aspects of our transportation infrastructure.

### **RECOMMENDATIONS BY CRTPA SUBCOMMITTEES**

On September 11, 2012, the CRTPA's two (2) committees (Citizens Multimodal Advisory Committee and Technical Advisory Committee) recommended CRTPA approval of the FY 2014 - FY 2018 Transportation Enhancements Priority Project List.

### **RECOMMENDED ACTION**

Option 1: Recommend the CRTPA Board adopt the FY 2014 - FY 2018 Transportation Enhancements Priority Project List.

### **HISTORY AND ANALYSIS**

Transportation Enhancement (TE) activities are broadly defined as federally funded, community-based projects that expand travel choices and enhance the transportation experience by improving the cultural, historic, aesthetic and environmental aspects of our transportation infrastructure. These types of projects expand travel options in ways other than through construction of traditional transportation projects such as roadway widenings.

A focus on such projects occurred with the federal passage of The Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991. With the Act's passage, the federal government required each state to set aside 10 percent of its Surface Transportation Program funds for Transportation Enhancement (TE) activities.

Twelve (12) TE activities have been designated by the federal government as eligible for TE funding. These activities are meant to improve non-motorized transportation, enhance the public's traveling experience, revitalize communities, and improve the quality of life. Specifically, the following are considered eligible:

- Provision of facilities for pedestrians and bicycles;
- Provision of safety and educational activities for pedestrians and bicyclists;
- Acquisition of scenic easements and scenic or historic sites;
- Scenic or Historic Highway Programs;
- Landscaping and Other Scenic Beautification;
- Historic Preservation;
- Rehabilitation and Operation of Historic Transportation Buildings, Structures, or Facilities (including historic railroad facilities and canals);
- Preservation of Abandoned Railway Corridors (including the conversion and use thereof for pedestrian or bicycle trails);
- Control and Removal of Outdoor Advertising;
- Archaeological Planning and Research;
- Environmental mitigation to address water pollution due to highway runoff or reduce vehiclecaused wildlife mortality while maintaining habitat connectivity; or
- Establishment of transportation museums.

## **CRTPA ENHANCEMENTS PROCESS**

The CRTPA coordinates the region's solicitation, ranking and submittal of eligible TE projects to the Florida Department of Transportation (FDOT) for annual funding consideration. Although the CRTPA annually submits a TE PPL, the agency actively solicits new applications <u>every two years</u>.

Once received, submitted applications are reviewed by the CRTPA Transportation Enhancements (TE) Subcommittee. The CRTPA TE Subcommittee is comprised of members from each of the CRTPA's committees.

The most recent CRTPA enhancement applications were solicited in 2011. The following contains the projects, along with project sponsor identified in parentheses, which are included on this year's TE PPL and were ranked last year by the TE Subcommittee:

- <u>Lloyd Railroad Depot</u> \* (Jefferson County) seeking funding (\$84,000) to continue the restoration of the Lloyd Railroad Depot;
- <u>Rustling Pines Boulevard Sidewalk</u> (City of Midway) seeking funding (\$350,454) to construct a sidewalk and bicycle lane on Rustling Pines Boulevard;
- <u>Martin Luther King/Peters Road Sidewalk</u> (City of Midway) seeking funding (\$787,349) to construct a sidewalk and paved shoulder on Martin Luther King Boulevard and Peters Road;

- <u>Brickyard Road Sidewalk</u> (City of Midway) seeking funding (\$1,431,816) to construct a sidewalk and paved shoulder on Brickyard Road;
- <u>SR 90 Welcome Sign</u> (City of Midway) seeking funding (\$8,800) to construct a new welcome sign on SR 90.

\* NOTE: Although ranked number one (#1) on the Draft FY 2014 – FY 2018 TE PPL, funding for the Lloyd Railroad Depot project is contingent upon the applicant meeting federal funding requirements associated with railroad depot projects. Such requirements relate to building ownership and potential repayment of funds associated with unforeseen events. The project applicant and sponsor are aware of these requirements.

Consistent with the CRTPA's enhancement process, the CRTPA will once again initiate the enhancement project solicitation in the spring of 2013\*\*.

### Changes from last year's (FY 2013 - FY 2017) TE PPL

Last year's number one ranked project (Lafayette Paseo) has been removed from this year's PPL due to the fact that the project received funding. The project proposes to complete the linkage of pedestrian, bicycle and transit systems along Lafayette Street in Tallahassee from the CSX Railroad Tunnel to Winchester Drive and has received funding in FY 2016 (\$519,000)(Work Program Project #4080493).

\*\* Based upon recent changes associated with the most recent federal funding bill for surface transportation (the Moving Ahead for Progress in the 21st Century Act (MAP-21)), the Transportation Enhancements process has changed. Such projects are now called Transportation Alternatives and will compete for funding along with other projects including Safe Routes to School and recreational trail projects. The CRTPA is awaiting further guidance from the FDOT and Federal Highway Administration. As a result, the CRTPA's program will change as the agency solicits projects in 2013.



### **HISTORY AND ANALYSIS**

In 2003, Florida's Legislature and Governor established Florida's Strategic Intermodal System, known as the SIS. The SIS is based on the 2020 Florida Transportation Plan (FTP), which calls for the development of a "strategic intermodal system" to enhance Florida's economic competitiveness. The FTP recommends that this system "provide for smooth and efficient transfers for both passengers and freight between seaports, airports, railroads, highways and other elements of the strategic intermodal system and reduce delay for people and goods movement through increased system efficiency and multimodal capacity."

### **CRTPA SIS FACILITIES**

The following roadways are on the Strategic Intermodal System (SIS) system in the CRTPA planning area:

- 1. Interstate 10 From Jackson County Line to the Madison County Line,
- 2. Thomasville Road from Interstate 10 to the Georgia State line,
- 3. Capital Circle, Northwest from Interstate 10 to the Tallahassee Regional Airport,
- 4. Tennessee Street/Mahan Drive from the Greyhound Bus Terminal to Interstate 10 (East), and
- 5. US 19 from the Georgia State Line to the Madison County Line.

The Draft FY 2014 – FY 2018 SIS PPL reflects those SIS projects that were identified for improvement in the agency's most recent update to the Long Range Transportation Plan ("The Regional Mobility Plan").

### Changes from last year's (FY 2013 - FY 2017) SIS PPL

Project Addition: Interstate 10 (west of US 90 to east of rest area) has been added to the list. This project is included in the agency's Regional Mobility Plan.



### STATEMENT OF ISSUE

Staff is seeking approval of the Fiscal Year (FY) 2014 – FY 2018 Tallahassee Regional Airport Priority Project List, included as Attachment 1.

### **RECOMMENDATIONS BY CRTPA SUBCOMMITTEES**

On September 11, 2012, the CRTPA's two (2) committees (Citizens Multimodal Advisory Committee and Technical Advisory Committee) recommended CRTPA approval of the FY 2014 - FY 2018 Tallahassee Regional Airport Priority Project List.

### **RECOMMENDED ACTION**

Option 1: Adopt the FY 2014 – FY 2018 Tallahassee Regional Airport Priority Project List.

### HISTORY AND ANALYSIS

Annually, the Capital Region Transportation Planning Agency (CRTPA) provides a listing of projects to the Florida Department of Transportation (FDOT), in priority order, for funding consideration. One of these lists is the Tallahassee Regional Airport Priority Project List. Unlike other lists adopted by the CRTPA, the Tallahassee Regional Airport develops this list. Projects contained on this list are consistent with the Tallahassee Regional Airport's adopted Master Plan.

The Tallahassee Regional Airport PPL provides guidance to the FDOT as the agency proceeds with development of the Annual FDOT Work Program. Ultimately, the projects included within the FDOT Work Program are included in the CRTPA's Transportation Improvement Program (TIP).

### PUBLIC INPUT

A public meeting to present the CRTPA's Draft FY 2014 – 2018 Priority Project Lists to the public was held on Thursday, August 30, 2012 at the Tallahassee Senior Center. Information regarding the meeting was advertised in the region's newspapers, placed on the CRTPA's website (<u>www.crtpa.org</u>) and an e-mail message regarding the meeting was sent to the agency's transportation partners.

### NEXT STEPS

Subsequent to adoption of the CRTPA FY 2014 – FY 2018 PPLs, the lists will be provided to the FDOT for use as the agency proceeds with development of the Draft FY 2014 – FY 2018 Annual State Work Program.

The Draft Annual State Work Program is scheduled to be presented to the CRTPA Board by the FDOT at the November 26, 2012 CRTPA meeting. Subsequent to release of the Draft State Work Program, CRTPA staff will initiate development of the CRTPA FY 2014 – FY 2018 Transportation Improvement Program (TIP) incorporating those transportation projects in the CRTPA region that have received state and federal funding.

### STATEMENT OF ISSUE

As required by financial and audit standards, the Fiscal Year 2013 Operating Budget has been developed for CRTPA Board adoption.

### **RECOMMENDED ACTIONS**

Option 1: Adopt by resolution the Fiscal Year 2013 Operating Budget.

### HISTORY AND ANALYSIS

The budget of the CRTPA is based on the tasks and revenues detailed in the Unified Planning Work Program, which covers staff operations in a fiscal year from July 1 to June 30. The host government for the CRTPA, the City of Tallahassee, operates on a fiscal year that begins on October 1 and ends on September 30.

There is a three-month gap that always occurs between the end of the CRTPA fiscal year and the end of the City fiscal year. This was duly noted in the CRTPA 2005 Financial Statement Audit dated March 1, 2006, and adopted by the CRTPA on March 27, 2006. Adoption of this resolution satisfies the intent of the management letter comment, as it has in previous years.

### **Budget Issues**

The proposed FY 2013 Operating Budget reflects the expenses anticipated to occur when completing the tasks adopted in the Unified Planning Work Program. Details of contents of budget items are provided below:

- Total Personnel Expenses include salaries, mandated employer costs for Social Security, Medicaid and health benefits.
- Operating costs include the cost of using services provided by the host government, the City of Tallahassee. This includes using human resources, accounting, purchasing, and information systems services. These costs are calculated by the city through a Full Cost Allocation Plan and charged to the CRTPA various factors related to CRTPA's utilization of services contracted by CRTPA the Staff Services agreement executed on May 21, 2012.

• Unclassified Contractual Services are for the cost of outside legal counsel, audit services WCOT broadcast services and retreat facilitators, when needed. This item remains the same as last year.

The revenue from grant reimbursements is expected to cover the expenses, with the exception of the local matching funds required for the Federal Transit Administration (FTA) Section 5303 grant and expenses not allowed under the grants. In the event that reimbursements do not fully cover the remainder of the costs, the difference will be prorated among member governments in accordance with the adopted CRTPA bylaws.

### Significant Changes from the FY 12 Budget

Adjustments have been made in the FY 13 budget in the following line items:

- Salaries increased to reflect a 2% salary increase for all personnel. This is in line with Leon County but less than the City of Tallahassee. The recommended increase would be effective on October 1.
- Health benefit and Pension costs increased more than expected.
- Costs for Allocated Accounts decreased in all area but significantly in the areas of Human Resource and Purchasing from FY12. The Staff will continue to work with the City on stablizing the City's Cost Allocation Plan costs from year to year.
- The line item for Computer Software was increased from \$10,000 to \$25,000. This to account for the addition of GIS services from TLC GIS authorized by the CRTPA Board earlier this year.

The increases shown above were offset by no increases or reductions in the following line items:

- Operating Expenses except as shown below remained the same as FY 12
- Office Rental and Maintenance was reduced slightly \$1803.

The budget adjustments for FY 13 resulted in a net increase over the FY 12 budget of 1.52% (\$11,429). This is a 1% decrease over the percentage of increase in FY 12. The increased costs will be covered by the grant funding CRTPA that is allocated each year by the State and Federal governments. Details of the adjustments are included in *Attachment 2*.

# FY 13 Budget Narrative

### Personnel Services

- 511000 The request for Salary Increases is to provide a 2% increase. This is in line with Leon County but less than the City of Tallahassee. The recommended effective date of the increase would be October 1. The percentage of increase on the budget page shows an increase of 2.4% over FY-12. The reason for this variance is that the salaries was incorrectly calculated as the result of a two step increase (1% in October and 1% in March). The salary amount should have been \$398,925 instead of \$397,367 (a difference of \$1558). A 2% increase to the correct salary amount (\$398,925) is \$7977 for a total of \$406,903
- 511500 Temporary Wages are requested this year to hire temporary help to assist in the update of the data needs for CRTPA staff. This will likely be a student intern during the summer months


### **Operating Expenses**

Operating expense categories remained the same with some minor adjustments as shown below with the expection of Computer Software and Maintenance. This last year the Board authorized the purchase of GIS software which the Tallahassee-Leon County GIS Department will maintain and utilize the assist CRTPA to enhance planning capabilities to do more comprehensive transportation planning analysis and graphically represent transportation data and plans that will be easier for the public to access and understand. Overall operating expenses increased by a little under 10%.

- 521180 Unclassified Contractual Services remains the same as FY12. Services with in this budget line item have reallocated as follows: Legal Services \$45,000, Audit Services \$22,000, WCOT Broadcast Services \$3500
- 521190 Computer Software and Maintenance is increased from FY 12 by \$15,000. GIS software and maintenance was added.
- 523010 Travel remains the same as FY12. This budget will allow for at least 3 Board members to attend MPOAC Institute Training for MPO Board members
- 524050 Office Rental and Maintenance Expense was reduce by \$1803 (12.50%) of FY 12

### Allocated Accounts

560000 Allocated costs decreased in all but one area most significantly in Human Resource and Purchasing from FY12. CRTPA staff has reviewed City's Cost Allocation Plan with City Budget staff and has been able to make some reductions. CRTPA staff will continue to work City budget staff to stabilize cost to reduce wide cost variation in the Human Services, Accounting Services and Purchasing.



### STATEMENT OF ISSUE

Staff is seeking approval of a resolution (*Attachment 1*) which would provide a work order to the consultant conducting the Monroe Street Access Management and Lake Ella Implementation Study to develop of a traffic signal warrant study near Lake Ella on Monroe Street.

### **RECOMMENDED ACTION**

Option 1: Approve by resolution a work order to conduct a traffic signal warrant study (\$34,500) and approve a related contract time extension (to March 31, 2013) to the contract for the Monroe Street Access Management and Lake Ella Implementation Study.

### HISTORY AND ANALYSIS

At the January 23, 2012 CRTPA Board meeting, the Monroe Street Access Management and Lake Ella Implementation Study was formally kicked off. As project development activities have proceeded, the CRTPA has received requests to investigate the need for a traffic signal at Lake Ella Drive (North)/Lake Ella Publix Plaza and/or Legion Street/On The Border intersection. To that end, a traffic signal warrant study is proposed to be developed by the project consultant.

Completion of a traffic signal warrant study will assist with development of the proposed median recommendations which seek to address pedestrian and vehicular safety issues along this segment of the corridor near Lake Ella. Currently, the project is anticipated to be completed by October 24, 2012; however, contingent upon Board approval of the proposed work order, the study's completion date is proposed to be extended to March 31, 2013 to ensure completion of the study.

The work order to conduct the signal warrant study involves an analysis of the above two intersection locations and will result in development of a technical memorandum containing the findings of the signal warrant analysis. The traffic signal warrant study analysis is estimated to cost \$34,500.

### PROJECT BACKGROUND:

The identification of improvements to the Monroe Street corridor in Tallahassee has been an agency focus of the Capital Region Transportation Planning Agency (CRTPA) for a number of years. This focus includes:

- <u>North Monroe Street Corridor Management Study</u>, approved by the Tallahassee-Leon County MPO in 1999, recommended the installation of a median at Lake Ella to provide pedestrians a mid-block refuge;
- <u>Tallahassee-Leon Bicycle and Pedestrian Master Plan</u>, adopted by the Tallahassee-Leon County MPO in 2004, identifying North Monroe Street at Lake Ella as a "pedestrian emphasis intersection";
- <u>CRTPA Transportation Systems Management (TSM) Priority Project List</u> designation in 2009 & 2010 of pedestrian safety improvements on N. Monroe at Lake Ella as the agency's number one TSM priority (funding for the installation of medians, scheduled to be constructed in 2015, was ultimately identified in 2010 and is part of the study associated with this agenda item);
- <u>North Monroe Street Design and Safety Study</u>, accepted by the CRTPA in September 2010, was developed for the agency by Florida State University Department of Urban and Regional Planning Master's students and provides student recommendations/ideas for the North Monroe corridor;
- <u>E. Sixth Avenue Sidewalk Project</u>, identified for funding in 2010, this project was included in the agency's Regional Mobility Plan and will improve pedestrian connectivity between Monroe Street and Gadsden Street (scheduled to be constructed in 2016).

In addition to the CRTPA, other transportation partners and agencies have identified projects and initiatives in the Monroe Street corridor, these include:

- <u>Sense of Place</u> initiatives (Midtown and Monroe-Adams) initiated in 2010 and 2011 by the Tallahassee-Leon County Planning Department include the Monroe corridor and identify support for improvements to facilitate increased pedestrian safety and economic development;
- <u>Frenchtown/Southside Redevelopment Area and Downtown Redevelopment Area</u> are both located along part of the Monroe corridor. The community redevelopment areas have funded improvements in the corridor including facade, streetscape and sidewalk improvements;
- <u>Downtown Tallahassee Pedestrian Connectivity Plan</u> was prepared for the Downtown Improvement Authority and completed in 2005. The plan identifies proposed improvements in downtown Tallahassee, including proposed medians for a portion Monroe Street in downtown Tallahassee where right-of-way is sufficient.

The Monroe Street Access Management and Lake Ella Implementation Study will build upon the above Monroe corridor efforts through development of a comprehensive assessment to address vehicular and pedestrian safety. As the study's name implies, the Monroe Street Access Management and Lake Ella Implementation Study contains two components.

- The first component involves a study of the entire Monroe Street corridor from John Knox Road (in the north) to just south of Magnolia Drive. The purpose of the study is to develop an initial access management strategy for the corridor that will include a strategy for the ultimate installation of medians.
- The second project ("Lake Ella Implementation Study") will focus on the Lake Ella portion of North Monroe Street (Tharpe Street to E. Seventh Avenue). As members will recall, funding for the installation of medians along this segment of the roadway is identified in the CRTPA's FY 2012 – FY 2016 Transportation Improvement Program (TIP). This portion of the study will result in the completion of the TIP project's first funded phase ("Planning Study") and will provide detailed access recommendations from which the funded project can proceed to its next phase (design). Funds for the design of this project are programmed in FY 2013 (\$172, 200); construction funds are programmed for FY 2015 (\$1,000,050).

Benefits of access management, which include the installation of medians, include:

- <u>Safety</u> Improved pedestrian safety due to reduced automobile/pedestrian conflicts; improved automobile safety (fewer and less severe accidents) as a result of reduced vehicular conflicts;
- Efficiency Higher corridor level of service for automobiles; less stop and go traffic;
- <u>Aesthetics</u> Access management results in less asphalt and more attractive corridors. The installation of medians allows for the addition of increased landscaping along the corridor. With regards to Monroe Street, a more attractive corridor assists with furthering the redevelopment efforts currently occurring along the corridor.

A key aspect of the study involves public involvement. Three (3) public meetings associated with the project are scheduled to be conducted (detailed below under "PUBLIC MEETINGS"). Furthermore, the Monroe Street Access Management and Lake Ella Study will be guided by a project team that will include the agency's transportation partners and corridor stakeholders.

Ultimately, the study will result in development of a corridor action plan that will include strategies and opportunities for proceeding forward with access management recommendations for the Monroe Street corridor. With regards to the Lake Ella portion of the study, the foundation to proceed forward with the next funded phase (design) of the median implementation project will be developed including the development of detailed access recommendations.

### PUBLIC MEETINGS

Two (2) of the three (3) planned public meetings have been conducted for the project. The first meeting occurred on March 6, 2012 at Tallahassee City Hall Commission Chambers. A total of forty-one (41) people signed in at this meeting and ten (10) written comments were received. The comments included concerns related to maintaining left turn access into businesses, support for pedestrian safety improvements (including a pedestrian refuge) and as well as support for landscaping any constructed medians. The second public meeting was held on Thursday, June 28, 2012 (5 pm – 7 pm) at Tallahassee City Hall Chambers and was attended by twenty-five (25) people.

Additionally, two (2) small group public meetings (focused on the North Monroe/Lake Ella and South Monroe segments of the Monroe Street corridor) occurred on May 16 & May 17, 2012, respectively. Invitations to attend these focused meetings were sent to the attendees of the March 6 public meeting who expressed interest in participating in a more refined segment specific discussion.

### PROJECT WEBPAGE

A project webpage (<u>http://www.crtpa.org/Monroe\_Median\_Project.html</u>) was created in March to provide project information and resources. The webpage provides project information related to upcoming meetings as well as a source for the presentations and documentation from previous meetings. The page also contains a comments link from which citizens can leave comments or questions about the study. Furthermore, resources related to access management including links to information about its impact on corridor businesses is provided.

### PROJECT TEAM

To date, the project team that is guiding the Monroe Street project has met five (5) times. The team is comprised of the CRTPA's transportation partners and includes representation from the Midtown Merchants Association, Downtown Improvement Authority, City of Tallahassee Economic and Community Development, Lafayette Park Neighborhood Association, Levy Park Neighborhood Association, Florida Department of Transportation, Knight Creative Communities, Tallahassee Public Works Department and the Tallahassee-Leon County Planning Department.

### NEXT STEPS

Upon approval of the recommended action, the project consultant will initiate development of the traffic signal warrant study as part of the Monroe Street Access Management and Lake Ella Implementation Study. The third and last public meeting is anticipated to be conducted this fall with the project scheduled to be subsequently presented to the CRTPA Board for approval.

A status report on the activities of the Capital Region Transportation Planning Agency (CRTPA) and other items of interest will be provided, including the following:

### • Wildflower Award

FDOT District 3 Maintenance – Midway Office won the Florida Federation of Garden Clubs, Inc., Ella P. Wood Paths of Sunshine Award for 2012. They were nominated by Commissioner Lynn Artz of Wakulla County. In the late summer of 2009, the Midway Office agreed to reduce the frequency of mowing the full right of way on US 98 between Woodville and Crawfordville Highways in order to preserve the native roadside wildflowers. Instead of mowing every 2 months, they now mow only twice a year and only during the period between November and February.

The first place award is \$500 of wildflower seed from the Florida Wildflower Growers Cooperative. The Florida Wildflower Foundation matched that award with another \$250 of seed from the same source. Jeff Caster of FDOT Central Office will be working with Midway to help them select the right species and a good site.

### • October 15, 2012 CRTPA Retreat

The retreat will be held at the Tallahassee Regional Airport from 9 AM to 1 PM. The retreat will focus on the new federal transportation legislation (MAP-21) and what is means to the Capital Region. Following the meeting, airport personnel will provide a tour of the airport for those who wish see the improvements that have been made to the airport over the last several years.

### • Leon County Community Traffic Safety Team Grant

CRTPA has been selected to receive highway safety funds in the amount of \$27,000 (see letter in agenda item 10 D (Correspondence). The funds will be used for the Leon County Teen Drivers Education and Outreach Program. Leon County currently has one of the high teen driver fatality rates in the State of Florida. The program is intended to reduce this high rate through education and outreach. The award was based on an application submitted by Lynn Barr and members of the Leon County Community Traffic Safety Team.





# The cost of America's inefficient sprawl

### The cost of America's inefficient sprawl

Editor's note: William Fulton is vice president for policy and programs at Smart Growth America, and a former mayor of Ventura, California. The views expressed are his own.

Earlier this month, Global Public Square addressed a critical issue at this moment in American history, as towns and cities nationwide look to bounce back from the recession.

"Why are U.S. cities going bankrupt?" is a question everyone should be asking, but the real answer isn't necessarily as straightforward as the one Fareed Zakaria suggested. Or perhaps it might be even simpler, depending on how you look at it.

It's true that pensions are an increasingly visible strain on city budgets. As the former mayor of Ventura – a California city that is *not* going bankrupt – I can attest that rapidly rising pension costs are a huge problem. But there are other, more fundamental factors driving cities to bankruptcy. Dealing with the underlying causes of poor revenue creation and out-of-control debt accumulation is a more nuanced – but ultimately more effective – solution to our country's economic woes.

The way in which we plan and build our towns and cities has a direct impact on how well they do. Financial resiliency and prosperity is woven into the very fabric of cities. Where businesses go, where houses go, where roads go, where sidewalks go, where farms and natural spaces go – all of these things collectively affect a community's economic performance and the cost of providing services there. Put things closer together, the services cost less. Put things farther from each other, the services cost more for the jurisdiction and its taxpayers. But in the case of many American towns and cities, we haven't always planned and built in this fiscally conservative way – and that's one of the biggest reasons why cities are struggling today.

When sprawling new development happens, it's easy to mistake that for prosperity. New buildings and wide roads look great when they first meet the eye. But over time, distant development costs more, gradually bleeding taxpayers and putting the hurt on municipal budgets.

Think about it. Every time a new, spread-out subdivision is built far away from existing infrastructure, somebody has to pay for a bunch of roads that serve a small number of residents. And sewer and water lines too. And fire trucks that must travel farther to serve fewer people. And police cars. And ambulances. And school buses. And dial-a-ride buses. And – in many parts of the country – snowplows.

The cost is enormous. One study in Charlotte, North Carolina, found that a fire station in a low-density neighborhood serves one-quarter the number of households and at four times the cost of an otherwise identical fire station in a less spread out neighborhood. That sort of inefficiency adds up and multiplies as you take into account the hundreds of services cities must provide. What seems cheap on the one hand isn't always when you look at it over the long haul.

Cities can sometimes stay in the black temporarily by approving new development and getting new revenue to pay for the costs. But that's really just a Ponzi scheme. When a real estate bust hits – as it did starting in 2008 – there's no more new development to subsidize sprawling development, and cities start to run in the red. That's partly what happened in Stockton and San Bernardino.

There's no silver bullet to fixing financial issues, especially ones as endemic as those facing America's towns and cities. But planning for the long-term, investing in existing communities, building in a fiscally prudent way and examining changes to real estate market demand are essential first steps.

Balanced budgets don't just happen. They happen because someone took the time upfront to check the costs and to evaluate what we can afford and what will add the most value. When we do a better job building with the future in mind and investing in what matters, rising pension costs and other secondary concerns will be more manageable.

# **STATEMENT OF ISSUE**

The purpose of this agenda item is to provide information on the upcoming update to the Congestion Management Process Report for the CRTPA.

# HISTORY AND ANALYSIS

As a Transportation Management Area, Federal law requires that the Capital Region Transportation Planning Agency (CRTPA) develop a Congestion Management Process Plan (CMP). The document serves to measure the system performance of transportation facilities within the planning boundary, and identifies various low-cost strategies that could be employed to alleviate congestion and maximize the mobility options available (such as operational improvements, initiation of park-and ride lots, increased transit service, etc.).

The CMP is a tool used by the CRTPA local governments when making decisions regarding the investment of resources in the transportation infrastructure of the region. As such, the report outlines a process whereby site-specific congestion management strategies can be identified, and recommended for future funding programming.

The current CRTPA CMP was adopted by the CRTPA in September of 2009, and is in need of an update.


# **RECENT ACTIVITY**

Under the CRTPA's General Consultant Contract, the CRTPA's Congestion Management Plan has been under review. Currently, segments of the CMP are being reviewed for data accuracy by Star Metro and the City of Tallahassee Traffic Engineering Department.

#### NEXT STEPS

Upon completing the initial accuracy review of specific segments of the CMP, the entire draft document will be released for intergovernmental review to ensure overall accuracy and to receive a technical analysis of the document. In November, the resulting draft will be formally released for review to the CRTPA committees, CRTPA Board, and the public for review. It is anticipated that the document will be ready for Final adoption in January of 2013.

The Gadsden County Bicycle and Pedestrian Facilities Master Plan was developed by Kimley-Horn and Associates and was adopted by Gadsden County on August 21, 2012. The Plan, which was funded through a Transportation Enhancement Grant awarded to Gadsden County through the Florida Department of Transportation (FDOT), outlines projects that Gadsden County is interested in pursuing locally and through the CRTPA planning process. The Plan includes maps and a section on funding strategies in addition to the Bicycle and Pedestrian recommendations related to Safe Routes to School, Blueways, Multiuse Trails, On and Off-Road Facilities, Recreational Cycling Facilities and local government policies.

The number one ranked project from the adopted plan is the Florida Arts Multiuse Trail, which is proposed as a 10 mile, paved, multiuse trail located on the south side of State Road 12 beginning in Quincy and terminating in Havana. This trail would have future connection to Eugene Lamb Jr. Community Park. The Plan can be viewed on the CRTPA webpage at www.crtpa.org under the "Documents and Projects" Tab.

# • Wakulla County Bicycle, Pedestrian and Blueways Master Plan

The Plan, which was funded through a Transportation Enhancement Grant awarded to Wakulla County through the FDOT, outlines projects that Wakulla County is interested in pursuing locally and through the CRTPA planning process. The Plan includes maps and a section on funding strategies in addition to the Bicycle and Pedestrian recommendations related to Safe Routes to School, Blueways, Multiuse Trails, On and Off-Road Facilities, Recreational Cycling Facilities, and local government policies. The Plan also includes eco-tourism planning tools including the development of Blueway Routes and Tours, a Mobile App for I-Phone (soon to be available on Android) and Wayfinding Plans.

The number one ranked project from the adopted plan is the Ochlocknee Bay Trail.


# **Plans Under Development**

• Jefferson County Bicycle and Pedestrian Master Plan

The Jefferson County Bicycle and Pedestrian Master Plan is currently under development by Renaissance Planning Group. The Plan will be similar in scope to the Wakulla and Gadsden Bicycle and Pedestrian Master Plans and will include maps, a section on funding strategies, and Bicycle and Pedestrian recommendations related to Multiuse Trails, On and Off-Road Facilities, Recreational Cycling Facilities and local government policies.

At the September 2012 CRTPA committee meetings, the consultant provided a brief introduction on the development of the plan, data received, and public involvement thus far on the project. Committee members were encouraged to be involved and provide comment on the draft plan, which is scheduled to be presented to Jefferson County for guidance in October of 2012. The exact date has not yet been set, but will be posted to the CRTPA webpage as soon as it is known. It is anticipated that the comments and guidance received on the plan in October at the Jefferson County Commission Meeting will be assimilated into a final plan to be adopted by Jefferson County in November of 2012. The adopted plan will be presented to the CRTPA Board at their respective November Meetings.

The adoption of this Master Plan will complete the series of comprehensive bicycle and pedestrian need analyses conducted for the four-counties that comprise the CRTPA area. These plans will be used heavily in the update to the Regional Mobility Plan, and in the application for and programming of funds for bicycle and pedestrian projects within the CRTPA area. The Department would be interested in meeting with the Capital Region Transportation Agency to discuss the operational concerns and possible funding opportunities in order to move this project forward.





# LEON COUNTY TRANSPORTATION DISADVANTAGED COORDINATING BOARD (TDCB) ACTIONS

The Transportation Disadvantaged Coordinating Board its regular quarterly meeting on July 11, 2012.
