Project Purpose:


Address opportunities to further implement SRTS policies, programs and projects to support Leon County public schools.

Regional Coordination

- What are your neighbors doing about safe routes to school?
 - New innovative ideas, success stories, lessons learned
- Regional alliances to promote change at the state level
 - Florida Administrative Code reasonable walking distance
 - Little recognition for student age or physical conditions
 - Florida Statutes hazardous walking conditions
 - Some recognition for students w/in 2 miles of school
 - Process is reactive
 - Limited authority for local officials
 - Limited recognition for student age
 - Other important factors not recognized

Countywide List of Priority Projects

- Aggregated from individual school audit reports
- Organized by school, improvement type
- To be included in the Regional Mobility Plan and the Transportation Improvement Program
- Under review February completion

Funding and Partnership Strategies

- Local, state and federal funding for infrastructure improvement projects
- State and federal safety grants
- Safety programs police department / sheriff's office coordination
- Work closely with the CRTPA on an ongoing basis!























Best Practices – you're not alone!

- School Board: take a stand for safe routes implementation
- Nurture the culture: sometimes we need a philosophical change to get everyone onboard
- Don't lose sight of non-infrastructure projects (i.e. programs and policies) – they can make a big difference
- Partner with governmental and nonprofit agencies as well as private enterprises are key
- Look for examples that work don't reinvent the wheel
