# A RESOLUTION OF THE JEFFERSON COUNTY BOARD OF COUNTY COMMISSIONERS, MEMORIALIZING THE BOARD'S POSITION WITH REGARD TO THE DUKE RAIL TRAIL AND THE SUN TRAIL MULTI-USE TRAILS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on February 7, 2019, the Jefferson County Board of County Commissioners ("Board") voted not to proceed with a Bike Trail Agreement with Duke Energy Florida, LLC for the construction and operation of a multi-use trail within the Duke rail bed in Jefferson County; and

WHEREAS, on December 15, 2022, the Board voted not to enter into a maintenance agreement with the State of Florida for County maintenance of the proposed Sun Trail Multi-Use Trail within Jefferson County; and

WHEREAS, the Board now wishes to adopt this resolution to memorialize these decisions with regard to the Duke Rail Trail and Sun Trail multi-use trails within the County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF JEFFERSON COUNTY, FLORIDA, that:

**SECTION 1. RECITALS.** The above recitals are true and correct and are hereby incorporated herein by reference.

**SECTION 2. BIKE TRAILS.** The Board hereby adopts this resolution to memorialize its current position in opposition to the County's construction of the Duke Rail Trail and County's maintenance of the Sun Trail multi-use trail within the County.

**SECTION 3. EFFECTIVE DATE.** This Resolution shall become effective upon its adoption.
