### B. Fiscal Year (FY) 2024 – FY 2028 Transportation Improvement Program (TIP) Amendment

This item seeks Board adoption of an amendment to the FY 2024 – FY 2028 Transportation Improvement Program (TIP) to include the following projects:

- <u>StarMetro Section 5339 Low or No Emission Grant</u>: Provides FY 2023 FTA money in the amount of \$8,004,790 and the City of Tallahassee match in the amount of \$2.4 million to fund StarMetro's Rolling Stock Project. This funding replaces four 35' and four 40' diesel buses with battery electric buses of the same size. (Leon County)
- <u>StarMetro Section 5339 Capital Items Project</u>: Provides FY 2023 FTA funding in the amount of \$12,366,002 and the City of Tallahassee local funding match in the amount of \$1,511,546 for the design, construction, and installation of Phase One of the Charging Infrastructure at the Appleyard facility, along with funding for workforce development. (Leon County)
- <u>SR 366/Pensacola Street from the Railroad Overpass to SR366/Stadium Drive:</u> Provides \$14,483,177 in federal, state, and local funding in FY 2025 for the resurfacing of Pensacola Street. (Leon County)

# **Meeting Minutes**

# 1. CALL TO ORDER AND ROLL CALL

The meeting was called to order at 1:35 pm with a roll call and a quorum present.

Board Action: Commissioner Minor made a motion to approve the consent agenda as presented. Commissioner Williams-Cox seconded the motion. The motion was unanimously passed.

### 7. CRTPA ACTION

### A. CRTPA Take the Safe Route – Safe Access to School Study

This item provided an update on efforts associated with the CRTPA's school safety study.

Mr. Burke stated the School Study was kicked-off at the January 2024, CRTPA Retreat and noted the study has moved forward since the retreat. He introduced the consultant, Lindsay Slautterback, Kimley Horn and Associates.

Ms. Slautterback provided background on the Take the Safe Route Study. She explained the study was aimed at ensuring students have a safe route to walk or bike to school and encourage a culture of walking and biking.

Ms. Slautterback explained the project was divided into two phases. She further explained the first phase included stake holder meetings, data collection, prioritization and identification of ten schools to further evaluate. Ms. Slautterback stated that during phase 2, student travel tallies and site visits will be conducted at the identified schools.

Ms. Slautterback discussed the analysis, prioritization and methodology used for the study. She stated the initial analysis that included geographic information system (GIS) based prioritization using school zone attendance, hazardous walking conditions, bike/ped crash data, socioeconomic and demographic data and other school related factors. Ms. Slautterback noted these were given value points to provide a score for each school with the highest score available of 20 points.

Next, she provided information on the preliminary schools identified and discussed that the next step involved conducting a desktop review. This review provided a further evaluation of the schools and used data related to residential density, existing bike/ped facilities, sidewalk connectivity, signage, and lighting. Ms. Slautterback discussed the final list of 12 schools within the region. She stated the next step (phase 2) included site visits to the final 12 schools for evaluation of existing conditions. She explained the purpose of the site visits was to identify needs for improvements to assist students with walking or biking to school. The visits evaluated the roadways, sidewalks, pavement markings and student movement patterns and initial observations identified safety concerns including the opportunity for

improved crosswalks. Ms. Slautterback noted the presence of school crossing guards was a major benefit and a good resource for information and feedback. Ultimately, she noted that the development of the final report will include the identification of potential improvements including small quick build projects and cost estimates for the improvements. She stated the final report will also include travel tallies and surveys.

Commissioner Richardson discussed the school zone at Nims and stated he observed a staff member of the school assisting students cross He noted that vehicles still roll through the lighted cross walk instead of stopping for students to cross. Commissioner Richardson asked if the newer schools being built with safe routes in mind and noted most schools on the priority list were older schools. Ms. Slautterback explained the data used included crash data, socioeconomic data along with stakeholder feedback and locations and noted it was possible because the newer schools are being built with the facilities. Commissioner Nesmith discussed the new school in Gadsden County and asked if there was any coordination with Gadsden County Schools. Ms. Slautterback stated the crossing guard at Shanks Middle School (Quincy), provided information on the new school. Mr. Burke stated that the Gadsden County stakeholder committee for the project included Gadsden County Schools staff. Commissioner Richardson noted the City of Tallahassee Commission voted on an initiative to install cameras in the school zones in the city with the hopes of slowing down traffic and hopefully with the combined efforts the students will be kept safe.

### Board Action: This agenda item was an informational item; therefore, no action was taken.

### B. Public Involvement Plan (PIP) Update

A discussion on the CRTPA's update to the PIP was provided.

Ms. Lex provided information on the Public Involvement Plan (PIP) Update. Ms. Lex stated as a part of this update, the ability to use a mobile device to review the information should be a big consideration because more citizens are accessing information from their mobile devices. She outlined the formal review schedule for the PIP update. She noted the comment period was open and there will be a 45-day comment period required by federal code. Ms. Lex stated comment period will close on June 17, 2024 when the PIP is presented to the Board for final approval. Ms. Lex provided an overview of the Federal code requirements and explained that Federal Code and Florida State Statute requires that MPOs conduct public involvement and have a Public Involvement Plan. Requirements include providing reasonable opportunities for all parties to participate and comment on MPO planning products. In the updated PIP public participation during regularly scheduled meetings provides a 7-day notice on all Committee Meetings and Board Meetings agenda items. She further explained another requirement relates to non-discrimination, and noted access to information, environmental justice and the requirement to review policies to identify inequities in the transportation planning process. Ms. Lex stated under Florida State Statutes, meetings have to be conducted according to the Sunshine Law which also requires meetings to be open to the public and to have records/minutes available to the public upon request. She explained when public meetings are held at the local schools, meeting are held after school hours and while children are not present as a part of the

Jessica Lunsford Act. Ms. Lex stated as a part of the major update, the plan has been revised to streamline the information on meetings, plans and programs on one page and noted the update includes information on Executive Committee and emergency meetings. Ms. Lex explained the goals to inform, involve, engage and collaborate. She noted the evaluation of engage strategies and techniques will be ongoing with an annual review and summary report. Ms. Lex explained the update to Title VI processes and forms will be presented separately for Board approval at the June 17, 2024, meeting and will become an appendix to the PIP. Employing visualization techniques is also an important component of the PIP and graphics will be incorporated in the final PIP. Ms. Lex noted the next steps after adoption, includes reformatting of document to include graphics by a consultant; any additional strategies and tools to incorporate innovative techniques and noticed as a minor update the PIP with another 45-day comment period.

Commissioner Williams-Cox asked what happens if the PIP was not adopted at the June Board meeting. Ms. Lex explained the document could be on the September agenda or an Executive Committee meeting could be scheduled to adopt the document.

### Board Action: This agenda item was an informational item; therefore, no action was taken.

### 8. FLORIDA DEPARTMENT OF TRANSPORTATION REPORT

A status report on FDOT activities was provided. Mr. Paulk provided information on changes to the Strategic Intermodal System (SIS) in the region as requested by the CRTPA. He outlined the additions and removals and noted that US 27 (I-10-Florida/Georgia state line) and Capital Circle, NE, and SE (Thomasville Road South/Southwest to the Airport) were added to the SIS and noted this corridor would now be the new Airport connector. Mr. Paulk stated that segment of Capital Circle from the Tallahassee International Airport north to I-10 has been removed from the SIS. Lastly, he discussed Crawfordville Road and noted that the Department would continue to seek opportunities for funding to move the corridor forward. Mr. Slay added the other addition that was requested be added to the SIS was Capital Circle NW (US 27 to I-10) and noted that although the Department didn't grant the request at this time Central Office would reconsider in the future. Mr. Slay noted the reasoning behind this request was the anticipation of the Amazon facility which currently remains inactive. He noted if that facility becomes active, CRTPA would request reconsideration of that corridor in the SIS. Mr. Slay noted that SIS facilities receive most of the funds from FDOT.

Commissioner Richardson asked for an update on Orange Avenue. Mr. Paulk stated that project was currently under the design phase and explained the plans are almost at 60% completion and that funding for right-of-way and construction is being sought. Mr. Slay noted the segment under the design phase for Orange Avenue was Monroe Street to Cypress Road.

Commissioner Williams-Cox ask if there was collaboration with Blueprint Intergovernmental Agency (BPIA) on the Airport gateway. Mr. Paulk noted that the FDOT was coordinating with BPIA.

### 9. EXECUTIVE DIRECTOR'S REPORT

A status report on CRTPA activities was provided. Mr. Slay stated the Safe Streets for All (SS4A) grant application was submitted for North Monroe Street and that the announcement (approving or denying) was anticipated in October of this year. Mr. Slay noted there would be a helmet fitter training on June 21, 2024, 10 am - 12 pm at the Frenchtown Renaissance Center, 435 N. Macomb Street.

Commissioner Messersmith thanked the CRTPA for the recent helmet fitter training in Wakulla County as well as providing assistance with the community event that was also held in Wakulla County.

Commissioner Minor thanked CRTPA and everyone involved in submitting the North Monroe Street SS4A grant application. Commissioner Minor noted the at the last BPIA workshop, the plan was adopted for Blueprint to provide the 20% match required for the grant and would be finalized when the budget gets adopted.

Commissioner Maddox asked about Crawfordville Road. He noted that at the last Leon County Board meeting, Commissioner Proctor stated this corridor should be an evacuation route. Mr. Slay noted the FDOT has funded about \$6 million in FY 26- FY 27 for ROW acquisition and the next step would be construction funding. He also noted that at the June 17, 2024, Board meeting the CRTPA is scheduled to adopt its annual priorities.

# **CRTPA ATTORNEY CONTRACT**

TYPE OF ITEM: Consent

# STATEMENT OF ISSUE

This item seeks a one-year extension of the CRTPA's legal contract with the Williams Law Group, P.A.

### **BACKGROUND AND ANALYSIS**

The agreement for legal services with the Williams Law Group, P.A. was executed in September of 2021 and most recently amended in September 2023. The initial contract with the Williams Law Group, P.A. was for a two-year term and includes an option to extend the agreement for one year. The contract extended in September 2023 making the current contract expiration date of September 2024.

Pursuant to Section 6 of the agreement, the contract may be amended from time to time and "the three years under this Agreement shall be for a two-year term with one, one year option to extend and further provided that funding approval by the CRTPA Board is obtained prior to renewal."

The proposed extension would expire in September 2025.

# **PROFESSIONAL SERVICES AGREEMENT**

THIS AGREEMENT for Professional Legal Services is entered into this <u>13</u> day of <u>September</u>, 2021, by and between the Capital Region Transportation Planning Agency, ("CRTPA") and the law firm of Williams Law Group, P.A. ("Law Firm") shall become effective on the date entered above.

WHEREAS, the CRTPA is a metropolitan planning organization designated pursuant to Section 339.175, Florida Statutes; and

WHEREAS, the CRTPA wishes to obtain the services of the Law Firm for the purpose of assisting the CRTPA in legal matters as referenced below in the Scope of Services; and

WHEREAS, the Law Firm wishes to render the legal services as required by the CRTPA as set forth in the Scope of Services;

**NOW, THEREFORE,** for valuable consideration and the mutual promises between the parties hereto, it is agreed as follows:

1. Scope of Services. The Law Firm shall perform the following services:

(a) <u>Routine CRTPA Meetings, Telephonic Consultation and Advice</u>. The Primary or Secondary attorneys, as set forth herein, will provide routine telephonic legal consultation with CRTPA Board members, the CRTPA's Executive Director (hereinafter referred to as "the Director") and the CRTPA Staff. The Primary Attorney will attend all CRTPA Board meetings, including the Board's semi-annual retreat, and pre-briefings as requested by the CRTPA Board Chairman or the Director, except when unforeseen situations arise outside the control of the Primary Attorney, in which case a Secondary Attorney may attend.

<u>Formal presentations at CRTPA Board meetings will be by either the Primary Attorney or a</u> Secondary Attorney, at the discretion of the Primary Attorney, unless the Director requests otherwise. The Primary or Secondary Attorneys will provide advice on routine CRTPA issues.

- (b) <u>Follow up Activities.</u> The Law Firm will perform follow up activities, as a result of matters addressed or considered during CRTPA meetings or the pre-briefing, at the request of the Director or the Board Chairman. Either the Primary Attorney, Secondary Attorneys, or other attorneys within the Law Firm may perform these follow up activities, unless the Director requests otherwise.
- (c) <u>Preparation of Presentations to CRTPA Board.</u> The Law Firm will prepare presentations to the CRTPA Board at CRTPA meetings at the request of the Director or the Board Chairman. The Primary Attorney, Secondary Attorneys, or other attorneys within the Law Firm may prepare these presentations, at the discretion of the Primary Attorney, unless the Director requests otherwise.
- (d) Legal Opinions. The Law Firm will provide legal opinions at the request of the Director, the Chairman or the Board. Legal opinions will be provided in a summarized written format suitable for either a presentation to the CRTPA, incorporating into the CRTPA Agenda or policy items. The Primary Attorney, Secondary Attorneys, or other attorneys within the Law Firm may perform research and writing, at the discretion of the Primary Attorney, unless the Director requests otherwise; however, presentations at CRTPA meetings will be in accordance with (c), above. The Law Firm will provide an opinion letter in response to the annual auditor's request for a description of all material pending and threatened litigation, claims and assessments against, CRTPA and related matters. As the Law Firm's practice areas do not include Statement of Financial Accounting Standards No. 5, no opinion will be

provided by the Law Firm in relation to the disclosure requirements of Statement of Financial Accounting Standards No. 5.

- (e) <u>CRTPA Policy Development</u>. The Law Firm will participate in the development and revisions of CRTPA policy, procedures, bylaws and governing documents, at the request of the Director. The Primary Attorney, Secondary Attorneys or other attorneys within the Law Firm may attend meetings and perform research, writing, and related work, at the discretion of the Primary Attorney, unless the Director requests otherwise; however, presentations at CRTPA meetings will be in accordance with (c), above.
- (f) <u>Litigation. The Law Firm will provide litigation support to the CRTPA at the request</u> and with the authorization of the Board Chairman or the Director. Either the Primary Attorney, the Secondary Attorneys or other attorneys within the Law Firm may provide these services, at the discretion of the Primary Attorney.
- (g) <u>CRTPA Contracts.</u> The Law Firm will participate in the preparation of contracts, contract negotiations, settlements, changes and the initial evaluation of protests at the request of the Director in conjunction with the City or County procurement offices, as needed. The Primary Attorney, Secondary Attorneys or other attorneys within the Law Firm may attend meetings, perform evaluations and research and writing, at the discretion of the Primary Attorney, unless the Director requests otherwise; however, presentations at CRTPA meetings will be in accordance with (c), above.
- (h) <u>Other Services.</u> The Law Firm shall render such other legal professional services as may on occasion be specifically requested by the CRTPA and duly authorized in writing by the Director or the Board Chairman. The Director or his designee shall be the coordinator for all CRTPA requests for legal services from the Law Firm and shall be responsible for ensuring the Law Firm provides the

requested legal services in a timely and satisfactory manner. The Primary Attorney, Secondary Attorneys or other attorneys within the Law Firm may perform these services, at the discretion of the Primary Attorney, unless the Director requests otherwise; however, presentations at CRTPA meetings will be in accordance with (c), above.

#### 2. Compensation.

(a) The Law Firm shall be compensated for professional fees with a monthly retainer as follows:

- For the first year, in the amount of \$14,100.00, (billed at 1,175.00, per month), and a rate of \$300.00 per hour for 3.9 hours per month for services rendered to the CRTPA as listed in paragraphs 1 (a) above.
- 2) For the second year, in the amount of \$16,000.00 (billed at 1,333.33, per month) and a rate of \$315.00 per hour for 4.23 hours, per month for services rendered to the CRTPA as listed in paragraphs 1 (a) above.
- 3) For the third year, in the amount of \$17,100.00, per year (billed at \$1,425.00 per month)\_ and a rate of \$325.00 per hour for 4.3 hours, per month for services rendered to the CRTPA as listed in paragraphs I (a) above.
- 4) The Law Firm will perform such services in excess of the monthly allocation hours upon conferring with and receiving written approval from the Executive Director to do so, and be compensated therefore at the hourly rate in paragraph 2(a) above. Should the Law Firm propose that additional compensation should be provided for such work, it will present its proposal and justification to the Director, who will have discretion to approve or disapprove such additional compensation based on CRTPA Board direction as provided for herein. All approvals for additional compensation will be made in writing.

- 5) The Law Firm shall be compensated at the billing rate per hour, as outlined herein, for services rendered to the CRTPA as listed in paragraphs l(b)-(h) above, and for all authorized services rendered as listed in paragraphs l(a) above, that exceed the budgeted allocated hours in any one month.
- 6) The Law Firm shall be compensated for all out of pocket expenses and other charges incurred in providing services under this Agreement.
- 7) On or before the 15th day of each consecutive month during the term of this agreement. the Law Firm shall prepare and submit an invoice for such fees. costs, and expense incurred in providing services doing the preceding month. Invoices will include the name of the attorney performing the work, a description of the work performed, hours expended during the billing period, cumulative hours on the specific task, the amount currently billed, and any prior due balances. Invoices shall be submitted to the Director, via e-mail, as designated by the Director. Invoices shall also provide detail as to specific and cumulative time expended, disbursements made, payments made to any certified DBE firms and other expenses incurred as may be required by the Director. Semi-annually, the Law Firm shall provide written documentation, which identifies the progress made toward the CRTPA's DBE goal of 8.5% participation.

### 3. Maintenance of Professional Standards and Malpractice Insurance.

The Law Firm shall maintain familiarity with the Code of Professional Responsibility of the Florida Bar and shall ensure that its representation shall be in compliance with the standards of conduct set by those rules. In the event of any questions concerning any potential conflict of interest between the CRTPA and any other client represented by the Law Firm, the same shall be disclosed to the Director immediately upon the issue being raised. The Director will develop a recommendation as to the conflict to present to the CRTPA Board for its

consideration.

#### 4. Insurance.

The Law Firm shall obtain and maintain malpractice insurance and shall provide documentation of same.

#### 5. Primary and Secondary Attorneys Professional Services Responsibility.

The legal services under this Agreement shall be provided by Thornton Williams, Esquire, as Primary Attorney, and Harriet Williams, Esquire, as a Secondary Attorney under this Agreement, and other attorneys within the Law Firm, when necessary, as described in paragraph 1, above.

#### 6. Term of Agreement.

This Agreement is for an term of three (3) years from the date first above stated, but may be amended from time to time, in writing, by mutual agreement of the parties. This Agreement may be unilaterally terminated for convenience by either party upon the providing of 30 days written notice to the other party. The three years under this Agreement shall be for a two year term with one, one year option to extend and further provided that funding approval by the CRTPA Board is obtained prior to renewal.

#### 7. Assignment.

This Contract shall not be assigned or sublet as a whole or in part without the written consent of the CRTPA nor shall the Law Firm assign any monies due or to become due to him hereunder without the previous written consent of the CRTPA.

#### 8. Indemnification.

The Law Firm agrees to indemnify and hold harmless the CRTPA from all claims, damages, liabilities, or suits of any nature whatsoever arising out of, because of, or due to the breach of this agreement by the Law Firm, its delegates, agents or employees, or due to any act or occurrence of omission or commission of the Law Firm, including but not limited to costs and a reasonable attorney's fee.

#### 9. Audits, Records and Records Retention.

The Law Firm agrees:

(a) To establish and maintain books, records, and documents (including electronic storage media) in accordance with generally accepted accounting procedures and practices, which sufficiently and properly reflect all revenues and expenditures of funds provided by the CRTPA under this contract.

(b) <u>To retain all client records, financial records, supporting documents, statistical</u> <u>records, and any other documents (including electronic storage media) pertinent to this</u> <u>contract</u> for a period of three (3) years after termination of the contract, or if an audit has been initiated and audit findings have not been resolved at the end of three (3) years, the records shall be retained until resolution of the audit findings or any litigation which may be based on the terms of this contract.

(c) Upon completion or termination of the contract and at the request of the CRTPA, the Law Firm will cooperate with the CRTPA to facilitate the duplication and transfer of any said records or documents during the required retention period as specified in paragraph 1 above.

(d) To assure that these records shall be subject at all reasonable times to inspection, review, or audit by Federal, state, or other personnel duly authorized by the CRTPA.

(e) Persons duly authorized by the CRTPA and Federal auditors, pursuant to 45 CFR, Part 92.36(1)(10), shall have full access to and the right to examine any of provider's contract and related records and documents, regardless of the form in which kept, at all

reasonable times for as long as records are retained.

(f) To include these aforementioned audit and record keeping requirements in all

approved subcontracts and assignments.

# STATEMENT OF ISSUE

The CRTPA Fiscal Year (FY) 2025– FY 2029 Transportation Improvement Program (TIP) has been developed for Capital Region Transportation Planning Agency (CRTPA) Board adoption by Resolution No. 2024-06-6A *Attachment 1*. The FY 2025– FY 2029 TIP is *Attachment 2* and can be viewed on the <u>CRTPA's website</u>.

# **CRTPA COMMITTEES ACTIONS**

The CRTPA's Technical Advisory Committee and Citizen's Multimodal Advisory Committee met on June 4<sup>th</sup> and both committees voted to recommend the CRTPA adopt Resolution 2024-06-6A approving the CRTPA FY 2025 – FY 2029 Transportation Improvement Program with minor updates to the maps.

# BACKGROUND

The purpose of the TIP is to inform the public and governmental agencies of transportation projects (planning through construction) that have received funding during the next five-year period (FY 2025–FY 2029) within our region (Gadsden, Jefferson, Leon, and Wakulla counties).

The CRTPA Transportation Improvement Program identifies regional transportation projects (roadway, bicycle and pedestrian, transportation systems management, transportation enhancement, public transportation, aviation, resurfacing and bridge projects) that have received funding in the Florida Department of Transportation's (FDOT) Draft Five-Year Work Program. The TIP is developed in accordance with 23 U.S.C. 134(h), 23 CFR 450 and Chapter 339.175(7), F.S., and is one of the annual requirements of the metropolitan transportation planning process for the CRTPA.

# AGENCY REVIEW

FDOT reviewed the draft FY 2025 – FY 2029 TIP and found that it includes the required content and that the projects are consistent with the state Five-Year Work Program. Appendix I contains the checklist completed by District Three staff.

# PUBLIC INVOLVEMENT

One virtual and two in-person public meetings were held to present the Draft FY 2025– FY 2029 TIP and the FY 2026 – FY 2030 Project Priority Lists (PPLs). These meetings provide the public an opportunity to learn about the CRTPA's programs and plans. Comment was solicited for both the TIP and PPLs.

Under the current public involvement plan a meeting must be conducted in one rural county and one in a location with access to public transportation. A meeting was held in Wakulla County at the library in the late afternoon to early evening. The second in-person meeting was held late morning through lunchtime at the Renaissance Center. The final virtual meeting, also held at lunchtime, was conducted on Teams.

These meetings were noticed in the local papers for each county, including an ad in both the Gadsden County Times and the Havana Herald. An advertisement was placed in the local paper of circulation for each county, as well posting the notice on the CRTPA website. The notice was published in each county's local newspaper, distributed to the CRTPA's committees and the Board, the Community Traffic Safety Teams, local governments and the emailed to the CRTPA contact list of stakeholders and citizens. The CRTPA and Wakulla County staff promoted the event on their Facebook page and by email.

Wakulla County administration and planning staff attended, as well as members of the Planning Commission and Community Traffic Safety Team. A few Wakulla County citizens attended and expressed interest in knowing when the existing SR267 widening project would be completed, concerns about environmental impacts of future construction, and a strong interest in seeing the widening of Crawfordville Road in both Wakulla and Leon counties. Appendix G of the FY 2025– FY 2029 TIP includes the publication notices for the meetings, materials and meeting attendance.

# NEXT STEPS

Subsequent to CRTPA Board adoption of the TIP, staff will transmit the document to state and federal review agencies.

# **RECOMMENDED ACTION**

Option 1: Recommend the CRTPA Board adopt by Resolution No. 2024-06-6A the FY 2025– FY 2029 Transportation Improvement Program.

- 5. The CRTPA requires the Executive Director to inform the CRTPA of all TIP amendments approved under these authorizations quarterly.

# **CRTPA COMMITTEES ACTIONS**

The CRTPA's Technical Advisory Committee and Citizen's Multimodal Advisory Committee met on June 4<sup>th</sup> and both committees voted to recommend the CRTPA adopt Resolution No. 2024-06-6B amending the CRTPA FY 2024 – FY 2028 Transportation improvement Program.

Adopted annually, the CRTPA's Transportation Improvement Program reflects those projects in the region that have received state and federal funding in the Florida Department of Transportation (FDOT) Five-year Work Program. Subsequent to adoption, the TIP is occasionally amended to reflect project changes, such as the addition or deletion of a project. StarMetro requested two transit projects, and the associated federal and local funds, be amended into the FY 2024 – FY 2028 TIP for informational purposes.

StarMetro was awarded a Low or No Emission 5339 competitive grant, which provides funding to state and local governmental authorities for the purchase or lease of zero-emission and low-emission transit buses as well as acquisition, construction, and leasing of required facilities. The FTA 5339 grant also requires a portion of the award be spent on training and workforce development. These two projects are added to FY 2024 in the TIP.

The last amendment, requested by the FDOT, is for a resurfacing project on SR 366/Pensacola Street that is programmed in the FY 2025 - FY 2029 TIP. For the purpose of authorizing federal funds, the FHWA recognizes the CRTPA's FY 2024 – FY 2028 TIP through September 30<sup>th</sup>, consistent with the federal fiscal year. The CRTPA's FY 2025 – FY 2029 TIP, to be adopted at this meeting, includes this project: thus, the amendment ensures consistency between the two documents. Subsequent to Board approval, the executed resolution and TIP project page will be forwarded to the FDOT and the FY 2024 – FY 2028 TIP will be updated to reflect the addition of these projects.



# **CRTPA COMMITTEE ACTIONS**

The Citizen's Multimodal Advisory Committee (CMAC) and the Technical Advisory Committee (TAC) met on June 4, 2024, and recommended Board adoption of the FY 2026– FY 2030 Project Priority Lists with revisions, with the exception of the Urban Area Attributable PPL, which is included for Board action. At the meeting staff informed the committees the PPLs were in draft form and would be finalized for the Board meeting. Since the committees' review, staff refined the project details associated with the Capital City Trails project, No. 3.

# BACKGROUND

The CRTPA annually adopts project priority lists that identify the ranked order of projects for which the agency is seeking transportation funding. Projects lists are developed for all modes of transportation. The CRTPA develops these lists in coordination with our modal partners, StarMetro and the Tallahassee International Airport, and state and local governments.

# BACKGROUND (CONT.)

Projects contained on the lists are established in the Connections 2045 Regional Mobility Plan; StarMetro's Transit Development Plan; Tallahassee International Airport's Aviation Master Plan; Regional Transportation Management Center's Intelligent Transportation Master Plan; and safety and multi-modal plans adopted by local governments in the CRTPA Region. For Board consideration the Urban Attributable (SU) Project Priority List is included. SU funds are allocated to the CRTPA as Transportation Management Area (TMA) and are used for planning, operations, project development and implementation.

### PROJECT PRIORITY CHANGES

- 1) <u>Roadways PPL</u>: Project Priority No.2, Capital Circle SW from Crawfordville Road to Springhill Road is fully funded and is removed from the list. The new No. 2 project is Crawfordville Road from East Ivan to Wakulla Aaron Road and subsequent projects all move up a ranking.
- 2) <u>Bike-Ped PPL</u>: Project Priority No. 3, Wakulla Springs Trail Extension, Wakulla Springs State Park to Springhill Road, replaces the previous priority, Old St. Augustine Road sidewalk project is fully funded for construction in FY 2025.
- 3) <u>Regional Trails Project Priority PPL</u>: This project list has been revamped. Trail Projects in Leon, Gadsden and Jefferson Counties are now presented as the Capital City Trail system, East, Central and West. Changes in the ranking are also proposed. Priority projects No. 1 and 2 are switched, making the SR 267 Trail No. 1 and the US 90 Trail No. 2. Priority project No. 3 is expanded to provide better detail related to the separate trail projects with the Blueprint Intergovernmental Agency and the CRTPA collaborating on developing this network.
- 4) <u>Intelligent Transportation Systems PPL</u>: There are no changes to the list.
- 5) <u>Tallahassee International Airport PPL</u>: The list is updated to reflect funded priorities and project funding.
- 6) <u>StarMetro PPL</u>: Project Priority Nos. 1, 2, and 3 are removed as these are fully funded. Phase II of the Electric Bus Charging infrastructure is added along with a new priority project for the expansion of the StarMetro administrative facility.
- 7) <u>Urban Attributable Funds (SU) PPL</u>: This list reflects the annual priority of funding for the CRTPA's Unified Planning Work Program for operational expenses and project development.

The Transportation Systems Management and Safety (TSM&S) PPL is not proposed for adoption at this time. Staff will reevaluate the feasibility of moving the three remaining projects forward, as well as identifying any new projects that support the safety and operations of the system and that can be completed in the short-term.

### PUBLIC INVOLVEMENT

One virtual and two in-person public meetings were held to present the Draft FY 2025– FY 2029 TIP and the FY 2026 – FY 2030 Project Priority Lists (PPLs). These meetings provide the public an opportunity to learn about the CRTPA's programs and plans. Comment was solicited for both the TIP and PPLs.

Under the current public involvement plan a meeting must be conducted in one rural county and one in a location with access to public transportation. A meeting was held in Wakulla County at the library in the late afternoon to early evening. The second in-person meeting was held late morning through lunchtime at the Renaissance Center (Leon County). The final virtual meeting, also held at lunchtime, was conducted virtually on Teams.

These meetings were noticed in the local papers for each county, including an ad in both the Gadsden County Times and the Havana Herald. An advertisement was placed in the local paper of circulation for each county, as well posting the notice on the CRTPA website. The notice was published in each county's local newspaper, distributed to the CRTPA's committees and the Board, the Community Traffic Safety Teams, local governments and the emailed to the CRTPA contact list of stakeholders and citizens. The CRTPA and Wakulla County staff promoted the event on their Facebook page and by email.

At the Wakulla County meeting, Wakulla County administration and planning staff attended, as well as members of the Planning Commission and Community Traffic Safety Team. A few Wakulla County citizens attended and expressed interest in knowing when the existing SR 267 widening project would be completed, concerns about environmental impacts of future construction, and a strong interest in seeing the widening of Crawfordville Road in both Wakulla and Leon counties. Appendix G of the FY 2025– FY 2029 TIP includes the publication notices for the meetings, materials, and meeting attendance. In addition, a citizen commented in support of the number one bike-ped priority project, Thomasville Road Shares-Use Path. Please see Attachment 8 for comments received on the PPLs.

# NEXT STEPS

Subsequent Board adoption of the CRTPA FY 2026 – FY 2030 PPLs, the lists are provided to the FDOT for consideration in the development of next year's Five-Year Work Program. In the fall of 2024, the FDOT will present the Draft Tentative Work Program for FY 2026 – FY 2030. After the Draft Tentative Work Program is released CRTPA staff initiates development of the CRTPA's FY 2026 – FY 2030 Transportation Improvement Program, incorporating the transportation projects in the CRTPA region that have received federal, state, and local funding.

At the June 4, 2024 CRTPA's Technical Advisory Committee (TAC) and Citizen's Multimodal Advisory Committee (CMAC) discussed the draft PIP. One comment was provided by the Citizen's Multimodal Committee that the graphic on Page 7 does not accurately reflect that each committee directly provides recommendations to the Board. This is noted in the attachment and will be updated as part of the final formatting by the consultant.

### **BACKGROUND AND ANALYSIS**

Public Involvement is at the center of the transportation planning process, as transportation networks affect the public in a variety of ways. The CRTPA's PIP essentially acts as a handbook that outlines the public participation methods, strategies for public engagement and outreach, and state and Federal regulations regarding public participation. As such, the PIP guides how the CRTPA conducts most of its public engagement activities and interacts with the public.

In an effort to provide quick access to key information the PIP layout was streamlined, providing the public with information on engagement opportunities during scheduled meetings and in the development of key planning documents and programs. The Goals, Objectives and Measures of Effectiveness are revised to establish four distinct objectives of the public involvement process; to inform, to engage, to involve and to collaborate with the public and stakeholders. Another key change is the updated PIP acknowledges that public engagement needs to be tailored to the particular project or program. This approach provides the opportunity to develop a meaningful public involvement process that is strategic and proactively seeks full representation from the impacted community.

### PUBLIC COMMENT

The major update to the PIP was initiated on May 2, 2024, and closes with Board approval at the June 17, 2024, CRTPA Meeting. This timeframe meets the requirement to provide a 45-day public comment period. Staff received one comment related to the processes for assessing and avoiding the impacts of projects on the environment and habitat. Another citizen inquired about the CRTPA and the agency's purpose. In addition, Tallahassee Reports mentioned in an article on the May 2024 CRTPA Meeting that the update to the PIP was presented the Board. Attachment 2 includes the public comments received as well as the Tallahassee Reports news article.

### NEXT STEPS

Following Board approval the PIP will be sent to a consultant for final formatting and to add supporting graphics. In addition, staff will update the strategies section to include more robust public involvement activities, the final Title VI process, and forms as well as the Civil Rights statement. This minor update will be noticed for a 45-day public comment period and then be presented to the Board for review and final approval in the Fall of 2024.

### General Guidelines

This Public Involvement Plan (PIP) provides guidelines for public participation in activities conducted by the Capital Region Transportation Planning Agency (CRTPA) and contains the policies, goals, objectives, and techniques used by the CRTPA for to encourage public participation. During the public involvement process, CRTPA will strive to:

1. Provide *timely information* about transportation issues and processes to citizens, affected public agencies, representatives of transportation agencies, private providers of transportation, other interested parties and segments of the community affected by transportation plans, programs, and projects (including but not limited to local jurisdiction concerns).

2. Provide *reasonable public access* to technical and policy information used in the development of the Long-Range Transportation Plan (LRTP), the Transportation Improvement Program (TIP), and other appropriate transportation plans and projects, and conduct open public meetings where matters related to transportation <u>plans/programs</u> are considered.

3. Give *adequate public notice* of public involvement activities and allow time for public review and comment on key decision points, including, but not limited to, approval of the LRTP, the TIP, and other appropriate transportation plans and projects.

4. **Document applicable public input**. When significant written and<u>/or</u> oral comments are received on the draft transportation plan (including the financial plan) or the TIP as a result of the public participation process or for a PD&E the interagency consultation process required under the U.S. Environmental Protection Agency conformity regulations, a summary, analysis, and report on the disposition of comments will be made part of the final plan.

5. Solicit the needs of those underserved by existing transportation systems, including, but not limited to, people with low-income, people with Limited English Proficiency (LEP), people who are transit dependent, people of color, older adults, and people with disabilities. Current federal law requires that the CRTPA provide reasonable opportunities for affected public agencies, representatives of public transportation employees, freight shippers, providers of freight transportation services, private providers of transportation, representatives of users of pedestrian walkways and bicycle transportation facilities, representatives of the disabled, and other interested parties with a reasonable opportunity to comment on the transportation planning process. [23 U.S.C. 104(d)1].

6. Provide a *public comment period of 45 calendar days prior to the adoption of the Public Involvement Plan* and/or any amendments. Notice of the 45-day comment period will be sent to local governments and distributed electronically and through social media, and the CRTPA website.

7. Provide a *public comment period of no less than 7 days* for any formal amendments, or updates, to the LRTP and TIP, and other appropriate transportation plans and projects.

8. *Coordinate the CRTPA's public* involvement *plan* with statewide, regional, and local public participation processes wherever possible to enhance public consideration of the issues, plans, and programs and to minimize redundancies and costs.

## Title VI (Environmental Justice)

No person in the United States shall, on the ground of race, color, national origin, or sex be excluded from participation in, be denied the benefits of, or otherwise be subjected to discrimination under any program or activity receiving Federal financial assistance (Title VI of Civil Rights Act of 1964, 42 U.S.C. § 2000d, and as amended, and the Civil Rights Restoration Act of 1987, P.I. 100.259). This includes funds received through the Florida Department of Transportation (FDOT) or other entities.

# **CRTPA - Organization and the 3C Planning Process**

#### **CRTPA – A Metropolitan Planning Organization**

The Capital Region Transportation Planning Agency (CRTPA) is the Metropolitan Planning Organization (MPO) responsible for the regional multimodal transportation planning for Gadsden, Jefferson, Leon, and Wakulla Counties, and the municipalities within. The Federal Highway Act of 1962 established legislation that mandated that an urbanized area (UZA) with a population of 50,000 establish a MPO and subscribe to a continuing, cooperative and comprehensive <u> $^{\circ}$  3C' Planning Process</u> in order to expend United States Department of Transportation (USDOT) funding.

The CRTPA's Metropolitan Planning Area (MPA) *Figure 1* extends beyond the urbanized area to include the counties of Gadsden, Jefferson, and Wakulla, the Capital Region. This four-county planning areas is also designated as the Metropolitan Statistical Area, *Figure 1* by the <u>U.S. Census Bureau</u>. A summary of federal and state regulations governing MPOs is provided in Appendix A.

Figure 1: CRTPA Metropolitan Planning Area Tallahassee Metropolitan Statistical Area (Census)

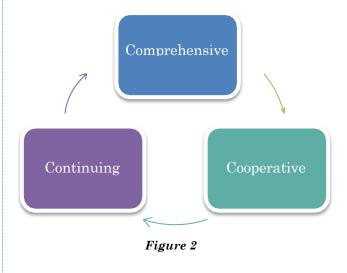
History of the CRTPA

1977 - The Tallahassee Urban Area Transportation Study Policy Committee was reorganized into the Tallahassee-Leon County (TLC) MPO.

Renamed to the CRTPA in 2004, the Metropolitan Planning Area (MPA) was expanded to include the urbanized portions of Gadsden and Wakulla Counties, along with expanded membership.

In 2008, the CRTPA planning boundaries and membership were again expanded to include all of Gadsden, Jefferson, Leon, and Wakulla Counties, as seen in Figure 1.

#### **3 C Planning Process**

Public Involvement is at the foundation of the 3C planning process *(Figure 2)* as transportation networks affect the public in a variety of ways. Therefore, the voice of the public is essential in ensuring that the transportation decisions made are efficient and effective in serving the community they impact. The CRTPA's Public Involvement Plan (documents the goals, objectives, and strategies that provides all users of the transportation system an opportunity to be involved in the transportation planning process. As the transportation network affects economic vitality, personal and freight mobility, and local/regional priorities, it is critical for the voices of everyone to be heard and considered.

#### Proactive, continuous, and inclusive public involvement assists in:

- Providing the public the opportunity to engage in the transportation-decision making process.
- Enhancing the development and implementation of transportation programs and projects.
- Promoting a thorough exploration of community needs, communications on objectives and trade-offs.
- Advancing more complete solutions that considers public input and examines a range of alternatives.
- Obtaining funding and support for projects and programs in the CRTPA Region.
- Increasing customer satisfaction, public trust, and public acceptance.
- Developing a better final product, especially context-sensitive solutions.
- Ensuring effective use of limited financial resources.



# Public Participation in the Planning Process



As part of the "3C" planning process and during every stage of the decision-making process consideration is given the principles of Environmental Justice and Title VI of the Civil Rights Act as relating to transportation systems and facilities.

### PART II - CRTPA BOARD, COMMITTEES AND STAFF

The CRTPA Board and staff are supported by the Technical Advisory Committee and the Citizens Multimodal Advisory Committee. Member representation provides input from a variety of sources. The governance [Board] structure is composed of elected officials from the four-county region and a Leon County School Board as voting members. The CRTPA's voting structure is a weighted vote and is established in the Interlocal Agreement. Representatives from StarMetro and the ARPC participate as non-voting members. Executive Committee members are the Chair, Vice-Chair, and immediate past Chair, with representation from Leon County, the City of Tallahassee (COT) and one rural local government.



Both the CMAC and TAC offer input from their varying perspectives, whether that be in a professional sense (planners, engineers, etc.) or from a citizen perspective (local residents). These committees garner feedback, input, advice, and provide recommendations for staff to present to the CRTPA Board.

### Citizens Multimodal Advisory Committee

The *Citizens Multimodal Advisory Committee (CMAC)* is comprised of individuals in the community and includes representatives of various agencies and transportation interests. Members of this committee must reside within the CRTPA Planning Area. The committee's purpose is to provide comment and guidance to the CRTPA Board on transportation planning and policy issues. The charge of the CMAC is to reflect a broad cross-section of residents within the CRTPA areas representing a wide variety of interests and special needs. Members must also be interested in the development of an integrated, safe, efficient, and cost-effective transportation network for all users. Special interests to be represented include child/youth advocates, minorities, off-road cyclists, pedestrians, persons with disabilities, road bicyclists, senior citizens, students, transit riders and the transportation disadvantaged.

### Technical Advisory Committee

The *Technical Advisory Committee (TAC)* is the CRTPA's technical committee and is comprised of local and state planners and engineers with expertise in the area of transportation planning, engineering, or management. TAC members provide technical reviews of CRTPA plans, programs, and projects and makes recommendations as to their need, feasibility, technical accuracy and consistency with local, state, and regional plans, programs, and projects. The TAC assists the CRTPA in carrying out the CRTPA's planning function through recommendations on various transportation issues. Another integral role of the TAC is providing technical expertise on steering committees, project working groups and their contribution as members of the Community Traffic Safety Team.

The CRTPA Board is comprised of 11 voting members representing Gadsden, Jefferson, Leon and Wakulla counties and municipalities. A list of <u>members and their contact information</u> is available on the CRTPA website. The CRTPA Board is the final level of review and decision-making body in the Agency's organizational structure. Recommendations from CRTPA staff and the committees are reviewed, discussed and then either approved, accepted, or rejected through a weighted vote. Annually, in January the Board holds a Retreat. **Public Involvement Plan (PIP)** - The Public Involvement Plan (PIP) identifies strategies to provide complete information, timely public notice, and full access to key decisions before adoption of or amendment to the CRTPA's plans and programs.

*Long-Range Transportation Plan (LRTP)* - Establishes the investment priorities established in the 2044 Connections Regional Mobility Plan (RMP), which is the CRTPA's LRTP. The plan fulfills state and federal requirements for a coordinated transportation plan consistent with local and regional goals; and that demonstrates the transportation projects are financially cost feasible.

*Priority Projects Lists (PPLs)* - Approved annually, the PPLs identify projects, or project phases, that the CRTPA seeks funding for in the Florida Department of Transportation's (FDOT) Work Program. Lists are developed for all modes of transportation; and list the region's transportation projects in priority order.

*Transportation Improvement Program (TIP)* - Approved annually, the TIP sets the schedule for improvements to the region's transportation system over the next five years. The TIP identifies local, state and federally-funded transportation projects in the FDOT Work Program; and Assigns available funding to specific projects and covers all modes of transportation in the Capital Region.

**Unified Planning Work Program (UPWP)** – The UPWP is a biennial statement of work identifying the planning priorities and activities to be carried out within a metropolitan planning area. At a minimum, a UPWP includes a description of the planning work and resulting products, who will perform the work, time frames for completing the work, the cost of the work, and the source(s) of funds.

### Public Involvement Plan

A guide to how the CRTPA conducts engagement in the development of program documents and projects, the Public Involvement Plan (PIP) is central to the transportation planning process. The CRTPA's Public Involvement Plan (PIP) identifies strategies and processes to provide citizens and stakeholders with reasonable public notice, complete information, and full access to key decisions before adoption of or amendment to the CRTPA's plans and programs.

Another critical component in the public involvement process is collaboration with local communities, and regional and state partners. It is important that the public engagement process consider the voices of leadership, stakeholders, special interest groups and the residents in the Capital Region.

At a minimum, the PIP will be evaluated and updated every three years. Updates will consider changing technologies, outreach strategies, and the success of the current plan's public engagement strategies and processes. An analysis of the effectiveness of the plan informs the staff and shapes recommendations for an update to the PIP. Necessary updates to comply with any new statutory requirement will be processed in a timely fashion in accordance with this plan.

- Draft PIP is presented to the TAC/CMAC & Board at the next regularly scheduled meetings.
- Reviews & comments will be solicited from FDOT, FHWA, & other partner agencies.

# PIP Adoption & Amendments

- •Comment period on the draft PIP closes after minimum of 45-days and as noticed.
- Public involvement activities & comments are recorded and included in the final document
- •A post is made to the CRTPA's social media accounts with a link to the final draft PIP.
- Final draft PIP adopted and website is updated accordingly.
- •Amendments follow the same process with the exception of updates to appendices.
- Updates to the appendix is to ensure supporting material is current.
- •Will be posted on the website and the update to the appendices documented in the PIP.

### Long-Range Transportation Plan

The Cost Feasible Plan (CFP), in the Long-Range Transportation Plan (LRTP), is the cornerstone of the transportation planning process. The CRTPA's adopted LRTP is the **Regional Mobility Plan** (RMP). Updated every five years, the LRTP provides a 20-year blueprint for transportation improvements and the expenditure of federal, state, and local transportation funds for the four-county region. This plan provides a common vision for the community's future transportation needs and is developed considering population, employment, and economic growth. The LRTP presents projection of anticipated transportation funding and costs for all modes of transportation, as well as for the operation and maintenance of facilities. Because funds are limited, public input is essential to help identify the priority projects and programs that will be included in the twenty-year plan for future implementation.

The public can provide input throughout the planning process and before the plan is fully drafted. Engagement with the public varies and could include workshops, surveys. outreach local governments to and information table at community events throughout the region, as well as through social media and digital platforms. Using virtual platforms and social media, citizens and community groups throughout the region are provided access to participate in the planning process. Comment may also be provided at scheduled TAC/CMAC meetings.

# Initiate Project & Public Involvement Plan

- Develop project webpage to include a schedule with ongoing project updates & meeting notices.
- Information on the LRTP update is included at annual TIP & PPLs community meetings.
- Updates & relevant project information is distributed as the plan is developed.

- Board recommendations and public comments are considered in the final draft for adoption.

# 14-day Public Comment - CFP Draft

- Posted for 7 days before the TAC/CMAC meetings and 7 days before the Board meetings.
- Notice to adopt final draft CFP at the next regularly scheduled CMAC/TAC and Board Meetings.
- Electronic notice is sent to regional & local partners, stakeholders & transportation providers.
- Electronic notice to local government administrators & if applicable, public information liaison.
- •Adoption Public Hearing proceeds final Board action on CFP at the regularly scheduled Meeting.
- If comment warrants significant changes the schedule will be adjusted for additional review.

# LRTP Amendments and Modifications

- •An *Amendment* is required to add, delete, or to make changes to a project scope or cost.
- •An RMP amendment is noticed 7-days before a public hearing and the adoption by the Board.
- Notice to adopt amended CFP at the next regularly scheduled CMAC/TAC & Board Meetings.
- Public can comment in writing via email or through the CRTPA website or at meetings.
- The amendment demonstrates that the project can be completed based on expected funding.
- •An Administrative Modification allows for minor changes to a project in the adopted LRTP.
- •The change is presented to the Committee and Board as an informaional item.

# **Project Priority Lists**

Each year the CRTPA is required to develop a list of projects, prioritize the projects, and provide the list to FDOT District Three by August 1 of each year. The adopted Project Priority Lists, PPLs, are updated in consultation with modal partners, local governments and FDOT. Development of the PPLS and public engagement is conducted concurrently with the development of TIP. All public involvement announcements and material include a discussion of the PPLs and request comment and input from the public and stakeholders. Projects are identified from adopted plans and documents prepared by the respective operator or modal provider.

- Electronic notice to local government administrators; & if applicable, public information liaison.
- Board action at a regularly scheduled meeting in May or June.

# **PPL** Amendments

- Comment period on Amendment begins with the posting of the TAC/CMAC meeting agendas.
- Distribute & notice the 7-day comment period in advance of the Board adoption.
- Finalize draft PPLs; include comments and address all comments.
- Electronic notice to local government administrator(s); & if applicable, public information liaison.

### **Transportation Improvement Program**

The TIP contains all transportation projects programmed in the Capital Region for the upcoming five fiscal years. It is updated annually to add a new fifth-year and to incorporate those projects in the CFP and PPLs having the highest priority and an ability to be funded. Projects in the TIP are grouped by modal types or category and then by county within each modal type or category. The TIP provides the year the improvement is scheduled, the source and amount of funding, and the agency responsibility for implementation. Project phases are provided as well as some level of detail regarding the project or program. From a policy perspective, the TIP reflects the priorities for scheduling improvements to the state highway system and federal Interstate highway system. It also includes freight, bridge, rail, and port improvements in addition to ITS strategies.

Each year, in May or June, the CRTPA updates its project priorities and includes them in the TIP document. The new priorities are used by FDOT for programming consideration in the upcoming new fifth year of FDOT's Work Program. Coordination with FDOT, StarMetro, local jurisdictions, and other partner agencies and transportation providers is ongoing throughout TIP development and after adoption

### TIP Amendments and Modifications -

- •Annually the TIP is updated to include the projects on Eastern Federal Lands.
- •An *Amendment* is required to add, delete, or to make major changes to a project scope or costs.
- •An *Administrative Modification* allows for minor changes to a project in the adopted TIP.
- The following page details the processes & opportunities for public comment on TIP changes.

# **TIP Modifications and Amendments**

Annually, in May or June, the Five-Year Transportation Improvement Plan is adopted for the upcoming [State] Fiscal Year, July 1 through June 30. However, the Federal Fiscal Year Cycle runs from October 1 through September 30. To ensure that required federal authorization of expenditures can occur during July, August, and September both the old TIP and the new TIP need to be consistent. This triggers the need for an Administrative or Roll-Forward TIP Amendment.

# TIP Modifications - Minor Change to a Project in the TIP

- •Minor change to project costs of less than 20 percent of total project cost & \$2 million.
- Minor change of additional funding source(s) or project initiation date for projects included.
- •A TIP Modification is included in the agenda package at the next regulary scheduled meetings.
- •The modification(s) is provided as an information item to the TAC/CMAC and the Board.
- No formal comment period on a TIP Modification, 7-day notice as part of the meeting agenda.

# TIP Amendments - Major Change

- Major change includes:
- the addition of a new project or the deletion of an existing project;
- a project cost increase of more than 20 percent & \$2 million;
- •design concept or scope change; project limits increase or decrease by a 1/2 mile & 20 percent.
- •A TIP Amendment may be time-sensitive due to FDOT deadline of the 10th of each month.
- •An amendment is processed immediately for Board action at next regularly scheduled meeting.
- •There is minimum 24-hour public notice of the Amendment to add it to a Board Agenda.
- •An Executive Committee meeting will be scheduled if necessary to meet deadlines.
- •The Amendment is ratified at the next regularly scheduled TAC/CMAC & Board meeting.

# Roll Forward TIP Amendments

- Project(s) is in any of the first four [Federally recognized] years of the old TIP.
- Project(s) was not authorized by June 30, but can still be authorized based on the old TIP.
- •TIP Amendment request must be made between July and September 30.
- Project to be Approved After September 30 Roll Forward Amendment
- •Need to ensure such projects are in the new TIP.
- •Accomplished by Roll Forward TIP Amendment which must occur before October 1.

# Administrative TIP Amendments

- In the new TIP (effective July 1) new projects may be added in Year One.
- However, this TIP is not recognized by FHWA until October 1.
- The project requires federal authorization prior to October 1.
- •Reflects minor changes to project, such as project phase costs, funding sources or limits.
- •The amendment is presented at the next regularly scheduled CMAC, TAC & Board Meetings.

# Unified Planning Work Program

The Unified Planning Work Program (UPWP) is produced on a biennial basis and serves as the CRTPA's work plan and budget for the two fiscal years. As such, it details the tasks and programs for which the CRTPA is responsible, associated expenditures and the funding sources. An initial draft UPWP is noticed for committee and board action. Concurrently it is transmitted for review to the Federal Transit Administration (FTA), the Federal Highway Administration (FHWA), and to the FDOT. These agencies provide comments. The final draft UPWP, addressing all comments, is then presented at a regularly scheduled meeting for approval by the committees and the CRTPA Board. At the time of the final draft UPWP is approved, the accompanying two-year contract with the FDOT is executed by the Board, which may be amended from time to time.

- Finalize draft UPWP, address all comments & include all necessary forms.
- ·Board adoption of the two-year UPWP includes the accompanying FDOT-CRTPA contract.
- Noticed for Board action on the UPWP & contract at a regularly scheduled meeting in May.

# **UPWP** Modifications and Amendments

### UPWP Modification

- •Minor changes, modifications, informational item FDOT & FHWA/FTA.
- •A modification does not change the total contract budget, add or delete a project.

### • UPWP [Minor] Amendment pursuant to the CRTPA Bylaws §IV.D.1. Administration

- Provides the Executive Director authority to approve a minor amendment, defined as:
  a onetime extension to an existing project schedule by no more than six months.
- a onetime amendment to an existing project scope and/or cost by no more than \$25,000.
- The amendment is subject to final approval by the Board, FDOT & FHWA.;
- UPWP Amendment (List of Amendment Thresholds)
- Follows the same 7-day comment period described for the final UPWP Adoption.
- Noticed for action at a regularly scheduled Board meeting; final approval by FDOT & FHWA.
- UPWP Amendment Time-Sensitive
- A UPWP amendment may be time-sensitive for an essential project or operations to continue.
- ·Amendment is processed immediately for Board action at next regularly scheduled meeting.
- •There is a minimum 24-hour public notice of the Amendment to add it to a Board Agenda.
- •An Executive Committee meeting will be scheduled if necessary to continue essential work.
- The Amendment is presented at the next regularly scheduled TAC/CMAC & Board meeting.
- •The amendment is subject to final approval by FDOT & FHWA.

# Federal Certification of the Transportation Planning Process

Every four-years, jointly, the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) must certify the metropolitan transportation planning process in Transportation Management Areas (TMAs). A TMA is an urbanized area, as defined by the U.S. Census Bureau, with a population of over 200,000. Pursuant to 23 U.S.C. 134(k) and 49 U.S.C. 5303(k). [23 C.F.R. 450.336(b)(4)]

As part of the certification process, FHWA and FTA provide opportunities for public involvement within the metropolitan planning area under review. The agencies consider the public input received in the final certification action. This process can be used by the CRTPA to improve the overall delivery of future public outreach based on the input received during the

public engagement. Additional primary activities include a review of the CRTPA planning products and a scheduled certification meeting to discuss the CRTPA responses to FHWA and FTA certification questions. Lastly is the preparation of a Certification Review Report by FHWA and FTA that summarizes the review and offers findings. The reviews focus on compliance with Federal regulations, challenges, successes, and experiences of the cooperative relationship between the CRTPA, FDOT and StarMetro in conducting the metropolitan transportation planning process. A final Certification Report documents the results of the review process. The and final actions are the joint reports responsibility of the appropriate FHWA and FTA field offices.

# Public Involvement and Federal Quadrennial Certification

### **Certification Process Initiated Every Four-Years**

- •The CRTPA Federal Certification process occurs, at minimum, every four years.
- · Post the schedule of certification activities along with the public engagement meeting date.
- FHWA and FDOT provide certification questions for response by the CRTPA.
- •Webpage is updated with CRTPA responses to the certification questions.
- · Comment may be provided throughout the process & at all public meetings.

# Certification Public Meeting

- •Meeting date & time is noticed a minimum of 7-days before scheduled public engagement event.
- The meeting will be held virtually and in-person providing for maximum accessibility.
- Distribute notice to local government administrators; if applicable, public information liaison.
- Send E-Blast to contacts list via email & social media distributing meeting notice.
- •A follow-up notice will be sent at minimum 7-days before the scheduled engagement.
- Public meeting presentations by the CRTPA and FHWA will be uploaded to the webpage.

# **Certification Report**

- •Webpage is updated with the draft (and if applicable) final Certification Report.
- •Any follow-up action is documented and updated on the Certification project page.
- The final report is noticed as part of the regularly scheduled TAC/CMAC and Board Meetings.
- •Meeting material is posted to the certification webpage.

# **Planning Studies and Reports**

Meaningful public involvement is a process that proactively seeks full representation from the community, considers public comments and feedback, and incorporates that feedback into a project, program, or plan. The process not only considers community contributions, but also encourages early and continuous public involvement and brings diverse viewpoints and values into the transportation decision-making process. It enables the community and agencies to make better-informed decisions through collaborative efforts.

The CRTPA conducts project, corridor, safety and/or specific area studies. These may be carried out by staff and/or consultants, and the scope, level of detail and products can vary greatly, as can the level of public involvement and engagement technique.

For such activities the public involvement is tailored to the project and is developed as project progresses. The CRTPA strives to identify affected parties and invite them to collaborate as stakeholders. The project website is updated regularly and at a minimum, the CRTPA will provide timely notification of all such plans or studies as they develop in draft form and to allow the public reasonable opportunity to review and comment on them.

# Public Involvement and Planning Projects and Studies

Project or Study Initiated

- •Webpage with the project overview and milestones is developed when project initiated.
- Updates & relevant project information is distributed as the plan or study is developed.
- •A project kick-off and/or updates are noticed and presented at regularly scheduled meetings.
- Comment may be provided throughout the process & at all public meetings.
- •All public comment is included as part of the project record.

# Acceptance or Approval of Final Report

- •Distribute notice to applicable, local government administrators; & public information liaison.
- ·Send E-Blast to contacts list via email & social media distributing meeting notice.
- Distribute notice to all parties that have provided their contact information for the project.
- The final report is noticed as part of the regularly scheduled TAC/CMAC & Board Meetings.
- •Meeting material is posted to the project webpage.

Citizen participation throughout the process helps to shape a plan or study by:

- Identifying the issues or problem statement;
- Defining goals, objectives, and prioritization factors;
- Developing alternative solutions;
- Reaching a consensus on the preferred alternative; and
- \* Reviewing and commenting on draft plans and studies.

### PART III - Public Involvement Goals, Objectives, Strategies

Goal 1: Provide accurate and timely information to the public about the CRTPA transportation planning programs, processes, and projects.

Goal 2: Make available a wide range of opportunities for the public and stakeholders to be involved and to stay engaged throughout the planning process, and plan or project development.

Goal 3: Collaborate with transportation planning partners, providers, stakeholders, and the public to support a continuous, comprehensive, and coordinated exchange of information, ideas and resources.

### Goal 4: Document and assess the success of the techniques and strategies throughout the process and evaluate the effectiveness of the Public Involvement Plan.

Strategies and Techniques: Public participation is an ongoing activity of the CRTPA, with several techniques occurring continuously. Public involvement is an integral part of both regular outreach and one-time activities such as corridor studies, and frequent activities such as the annual TIP process, or LRTP updates. The strategies implemented through the PIP revolve around the activities of the CRTPA's advisory committees and outreach efforts conducted by CRTPA staff. This section of the PIP describes these strategies as well as implementation during the process.

*Evaluation:* Throughout the year the CRTPA staff will evaluate the effectiveness of the public participation strategies and outreach. A summary document will be completed annually on the measures of effectiveness.

Annual documentation will include, at a minimum: Attendance at various meetings such as the CRTPA Board Meeting and project and plan specific meetings; Highlights of social media posts; Updates to contacts list and project distribution lists; Involvement in community events, CTSTs, and educational/informational meetings; Surveys taken and the results; and, Presentations made to public groups

### **Objective** – To Inform

# To inform and educate the public and stakeholders about the transportation planning process and the role of the CRTPA.

- ◆ To provide the community with a balanced and objective information.
- To assist the public with accessing information and understanding the planning process and documents.
- To present citizens with comprehensive information on transportation projects, issues, alternatives, opportunities and/or solutions.

*Public Notice:* A Public Notice is a form of advertisement for CRTPA meetings, events, workshops, plans, or plan updates.

*CRTPA Website:* See The website is continually updated and maintained by CRTPA staff. The CRTPA website is the primary location of the most up-to-date information regarding all CRTPA activities. The website may be accessed at: <u>CRTPA.org</u>.

*Social Media:* The CRTPA utilizes two different Facebook accounts to distribute information, promote meetings and events. recognizes the importance of reaching out to communities through social media. These platforms are used to communicate information to the public as well as providing a means for the public to communicate back with comments or questions. Additionally, the CRTPA coordinates with local agencies/municipalities to leverage their social media resources for all relevant projects and plan updates.

*Legal Advertisements:* The LRTP requires a Public Hearing as it contains federal and state funded major transportation improvements. FDOT defines a major transportation improvement in accordance with state law (Chapter 339.155, F.S.) as a project that increases capacity, builds new facilities, or provides new access to limited-access facilities.

**Press Releases:** General or official notifications are distributed to different media sources to inform the public of upcoming and ongoing transportation projects or other CRTPA related activities.

*Email Communication:* The CRTPA sends out e-blast notifications to partner agencies, stakeholders, and citizens that have requested to be notified about CRTPA meetings, activities, and document reviews. To be added to the CRTPA's email list, a request may be submitted through the <u>CRTPA Contact-Us link</u>.

*Community Meetings: Virtual and In-Person* Community Meetings are held to solicit public opinion as related to a wide range of CRTPA sponsored activities. They are utilized in a variety of different planning activities from the development of individual projects all the way up to area-wide activities such as development of the LRTP. These meetings may be virtual or in-person, and can be designed broadly for an area wide attendance or specifically targeted towards individual groups such as civic organizations, homeowner's associations, special-interest groups, municipalities, and local-elected officials.

**Project Update Meeting:** An important strategy and type of community involvement meeting designed to keep the public informed on the progress of specific projects, plans, or studies. These meetings are outlined in the project public involvement plan. Additional meetings may be scheduled in response to ongoing public involvement.

*Civic Groups:* Civic Groups are specifically engaged in order to assemble diverse perspectives from groups that are organized around a common interest or in pursuit of a common cause. These groups can be composed of, but not limited to minorities, low-income citizens, the physically challenged, and/or the elderly.

*Newsletters:* Newsletters are used to inform the public about the activities of the CRTPA or provide status updates on current or upcoming projects. They can be general in nature by providing quarterly or yearly synopses of CRTPA activities or more project-specific by focusing on individual phases of ongoing projects, plans, or studies.

*Maps:* Printed maps are used in every type of CRTPA public involvement activity to provide a visible reference so participants are able to more effectively relate to the data that is being presented. Maps can be as small as a sheet of paper for inclusions in hand-outs or packets, or as large or larger than 'poster-size' to be openly displayed during meetings.

*Surveys:* Surveys are a standardized and structured method of soliciting input about specific topics, plans, or projects from the public. Surveys can also be used to collect technical or quantifiable data such as travel pattern information, number of miles driven to work, or average number of trips driven per day.

*Comment Forms:* Comment forms or comment cards are used to solicit open ended public input about specific topics or presentations at public workshops or meetings. They also allow the public to provide input anonymously.

**Posted Mail:** Traditional mailings are utilized to notify individuals and/or organizations about upcoming meetings, hearings, or the status of a specific project. Posted mail can be postcards, flyers, agendas, newsletters, or letters.

*Sign-in Sheets and Contact Database:* All CRTPA sponsored events utilize sign-in sheets to record citizen participation and interest in receiving communications. A contact database is maintained by CRTPA staff or contracted consultants. Contact databases are used to notify previous participants about developments in a specific project, and interested parties to receive information about significant upcoming events.

*Social Media:* The CRTPA instituted the use of social media via Facebook to disseminate information and updates about the construction of the Capital City to the Sea Trail. Social media serve as a tool for announcing CRTPA meetings, draft and final documents for public review, and staff/ committee or board announcements.



# **CRTPA Identifies "Take the Safe Route" Schools**

On May 21<sup>st</sup>, the Capital Region Transportation Planning Agency (CRTPA) held their monthly meeting and discussed the "Safe Access to School Study" and their Public Involvement Plan.

The Board received a presentation from staff on Phase 2 of the CRTPA's "Take the Safe Route – Safe Access to School Study". This study was developed in two phases, the first being a comprehensive study of schools in the CRTPA Region (elementary, middle and high school) to identify those with the greatest need for capital improvements related to biking and walking facilities. Phase 1 identified 12 schools in the CRTPA region.

The Leon County schools identified include, Amos P. Godby High School, John G. Riley Elementary School, Raa Middle School, Ruediger Elementary School, Griffin Middle School, Leon High School, Nims Middle School, Rickards High School, Pineview Elementary School and Fairview Middle School.



The timeline for the implementation of the CRTPA "Take the Safe Route" program.

Staff explained that Phase 2 of the study (which was recently initiated) will involve an analysis for the recommended schools in Phase 1. This analysis includes on-site visits and an inventory of the existing facilities and infrastructure at the selected schools. The assessment will consider things such as sidewalk gaps, lighting and intersection improvements.

The Board was also given an update by staff on the CRTPA Public Involvement Plan (PIP) update. The CRTPA's PIP contains the policies, goals, objectives, and techniques used by the CRTPA to encourage public participation. Staff noted a major update is that information regarding CRTPA's meetings, plans, programs have been streamlined onto one page to make the information more accessible to the public.

Additionally, staff noted some of the desired outcomes of developing the PIP will be providing adequate public notice of public participation activities and time, providing timely notice and reasonable access to information, and holding public meetings at convenient and accessible locations and time.
