



- Intermittent bicycle and pedestrian accommodations








#### **Previous and Ongoing Corridor Efforts**

- » CRTPA Efforts
  - Safe Streets and Roads for All Safety Action Plan
    - High Injury Network (Data provided by CMP effort)
    - Continued emphasis in the area
  - Congestion Management Plan
    - Safety considerations
  - Sidewalk implementation with agency assistance
- » Leon County Sheriffs Office
  - Community Traffic and Safety Team
  - Homeless Outreach Street Team (HOST)

#### **Homeless Population Concentrations**






#### **Previous and Ongoing Corridor Efforts**

- » Agency Efforts
  - FDOT Median modification (ongoing)
  - FDOT Completed (2023) and planned resurfacing (2027)
  - Recent signalization (Talpeco Rd.) FDOT/CRTPA
  - Sidewalk implementation John Knox to Lake Shore CRTPA/FDOT
  - Mid-block crossing (Lake Ella) CRTPA/FDOT
  - N Monroe Corridor Action and Management Plan -TLCPD
  - Citizens' N Monroe Corridor Task Force TLCPD
  - Safe Routes to School Leon County
    - Sidewalks at Canopy Oaks Elem., and School of Math and Sciences
  - Outreach completed late 2023 TLCPD

Vehicular Transportation: Are there any transportation enhancements you would recommend to improve conditions for people driving on North Monroe Street north of Interstate-10?








#### **Identification of Existing Conditions**

- » Travel Trends
  - Volumes of movement
  - Origins/destinations
  - Identification of conflict areas



#### Bicycle and Pedestrian Crashes (2018-2022)



## Anticipated Needs, Recommendations, and Considerations


- » Data to be Reviewed
  - High crash locations
  - Bicycle and pedestrian crashes
  - Lighting considerations
  - Intersection geometry
  - Corridor conditions
  - Movement volumes
  - Turning movement





# Anticipated Needs, Recommendations, and Considerations

- » Example Recommendations
  - Intersection design changes
  - Improved markings
  - Pedestrian Flashing beacons
  - Fill sidewalk gaps
  - Lane narrowing
  - Speed monitoring
  - Lighting improvements
  - Mid-block crossings
  - Signal timing adjustments
